October 2016. This also applies to all 2018 5* Jumping events and 2019 FEI World Cup[™] Western European League and North American League Events (Jumping).

FEI Nations Cup[™] Jumping - re-opening of bid applications

Further to a decision taken by the FEI Bureau during its teleconference earlier this month, the bids for the **FEI Nations Cup™ Jumping Final 2017 and 2018** as well as the **FEI Nations Cup™ Jumping 2017 – Europe Division 1** have been re-opened. National Federations wishing to host the event are requested to submit their bid applications **by 5 September 2016** to **bidding@fei.org**. The bids will be evaluated by the FEI Jumping Committee. The allocation will be made by the FEI Bureau.

For all FEI Dressage and Para-Equestrian Dressage Stewards, please be aware of the following addition to the Stewards Manuals of these disciplines:

"To be able to check the presence of ear plugs, the ear hoods have to be removed after the test, when the bits and spurs are checked. The steward has to witness this."

Para Dressage New Classification Management in 2017

In order to comply with the IPC Classification Code and the IPC International Standard for Athlete Evaluation, the application process for FEI classification will be centralised and managed through the FEI Headquarters as of 01 January 2017. FEI classification will then only be offered at specific CPEDI events previously determined by FEI Headquarters, following consultation with the FEI Classification Working Group, the FEI Para-Equestrian Committee and the National Federations that will host CPEDI events throughout the calendar year. Where multiple CPEDI events are held within one National Federation, the NF will be asked to nominate which event will offer FEI classification. The respective Classification Calendar for 2017 will be published in November 2016. More details on this new process and the respective Classification Request Form is published on **Inside FEI.org**.
