The FEI Board has approved changes to the FEI Equine Prohibited Substances List (EPSL) brought forward by the FEI List Group. These changes have been published on **Inside.FEI.org** so that our National Federations and Athletes and their entourage can start the process of familiarisation with the changes.

The changes to the EPSL will come into force on 1 January 2022.

The consultation process for the 2023 FEI Equine Prohibited Substances List process will commence early in 2022.
