# A. PROPOSED RULES CHANGES TO BE VOTED AT THE FEI GENERAL ASSEMBLY 2023

## Proposal from (National Federation, Stakeholder or FEI)

EEF, AUT NF, GBR NF, GER NF, ITA NF and SWE NF

6.5.2 – Discipline Committees

## Explanation for Proposed Change

In order to recognise the importance of youth for our sport, we propose to add a mandatory youth expert to each FEI Discipline Committee. Such expert, regardless of age, shall be an experienced person who is particularly involved in the sport at youth level.

This follows the wish expressed by Chefs d'Equipe of EEF nations and underlined in a meeting during the Jumping Nations Cup Youth Final 2022, Kronenberg (NED) 20-25 September 2022, and a subsequent discussion in the EEF Group Meeting at the 2022 FEI General Assembly.

Following a recommendation of the FEI Strategic Planning Committee back in 2006, the Pony Riders' and Children Riders' Committees were dissolved in 2008 in a step to create a Youth Committee, which in the end has never been installed. But young people are not a static target audience. Therefore, we are not in favour of taking up again the idea of an extra Youth Committee. Instead, we are of the opinion that having a person in each of the disciplines' Committees who is aware of and speaks up for the specific needs of youth athletes is the best way forward.

Our goals are:

- To attract young people to equestrian sport and maintain their interest so that they don't quit they are our future;
- To ensure equestrian sport stays relevant within a highly competitive youth market;
- To accommodate the need for greater interaction with those involved in the sport at youth level;
- To ensure that someone looks after all youth related activities in the respective discipline;
- To take care of the needs of the younger Athletes to optimize their potential;
- To increase the possibility of youth Athletes making the transition to senior level.

#### Proposed wording:

"Each Discipline Committee shall be composed of the Chair and five (5) other members with proven knowledge and experience (such as but not limited to Officials, Athletes, Organisers, Chefs d'Equipe, trainers, owners, grooms, <u>youth Athletes</u>) in the relevant Discipline. <u>A youth representative and Aan Athlete representative must be a member of</u> each Discipline Committee, although <u>neither</u> the Athlete <u>or youth</u> representative may <del>not</del> serve as Chair or Deputy Chair during their term in this capacity."

#### Proposed Wording on 28 June 2023

None.

The FEI Board discussed this proposal at its in-person meeting on 6-7 June 2023. The FEI Board acknowledged the significant relevance of youth, which represent the future of the equestrian sport, as well as the need to keep on working around a range of youth initiatives. However, the FEI Board agreed that populating a specific seat in the Discipline Committees



by a youth representative was not the best way of tackling this topic and many questions were raised by this proposal, e.g. what is the definition of a youth representative?

Instead, the FEI Board is of the opinion that youth related topics can be efficiently covered through current Article 6.7 of the Internal Regulations which established that "Youth shall be the competence of Discipline Committees and each Discipline Committee shall have Youth as a mandatory Agenda item for each meeting".

The FEI Board requested the Technical Committees to apply Article 6.7 consistently.

## - GBR NF:

Inclusion of a Youth representative on the Discipline Technical Committee. We do not believe that the FEI Board feedback goes far enough in this area.

"Instead, the FEI Board is of the opinion that youth related topics can be efficiently covered through current Article 6.7 of the Internal Regulations which established that "Youth shall be the competence of Discipline Committees and each Discipline Committee shall have Youth as a mandatory Agenda item for each meeting". The FEI Board requested the Technical Committees to apply Article 6.7 consistently. In addition, a reference to Youth could be included in the Job Descriptions for Technical Committee members to also cover this subject".

We would like it noted that we believe that it is not necessarily a pre-requisite to be a youth athlete to have a full and comprehensive understanding of the Youth Groups. This could be someone who works specifically within this area in a different capacity, whether as a coach, chef d'equipe, or performance manager. This would broaden the pool of potential candidates, with the appropriate knowledge and experience for Committee membership.

## PROPOSED WORDING:

"The Discipline Technical Committee shall strive to have at least one representative from the Youth Group Community".

## NED NF:

Although we understand the FEI feedback on this proposal, we do believe that only putting Youth as mandatory agenda item is not sufficient. We propose that one of the committee members should have youth topics in their portfolio and therefore is responsible for always keeping it at the forefront.

"Each Discipline Committee shall be composed of the Chair and five (5) other members with proven knowledge and experience (such as but not limited to Officials, Athletes, Organisers, Chefs d'Equipe, trainers, owners, grooms, youth Athletes) in the relevant



Discipline. A youth representative and A an Athlete representative must be a member of each Discipline Committee, although neither the Athlete nor the youth representative may not serve as Chair or Deputy Chair during their term in this capacity."

#### FEI Feedback

The FEI reiterates its commitment towards the promotion and encouragement of youth as a key stakeholder; equally important as other stakeholders.

It is necessary however to find the most effective way of handling youth matters by Technical Committees within the FEI Governance framework.

After having carefully considered National Federation's feedback, the FEI Board agreed to include a reference to "youth" in this Article as proposed below; in addition to the existing reference to "Youth" in the Internal Regulations of the FEI.

Proposed Final Wording to be Voted at the FEI General Assembly 2023

"Each Discipline Committee shall be composed of the Chair and five (5) other members with proven knowledge and experience (such as but not limited to Officials, Athletes, Organisers, Chefs d'Equipe, trainers, owners, grooms, <u>a member with knowledge of youth</u> <u>matters</u>) in the relevant Discipline. An Athlete representative must be a member of each Discipline Committee, although the Athlete representative may not serve as Chair or Deputy Chair during their term in this capacity."

Explanation for Proposed Change

Clarify that Deputy Chairs can serve a maximum of three (3) full Terms, similar to the term of Regional Group Chairs.

#### Proposed Wording on 28 June 2023

"To nominate a Deputy Chair from among the National Federations of the Regional Group for election by the General Assembly, with whom they shall work closely and cooperate in furtherance of the tasks and responsibilities above. The Deputy Chair shall not be from the same National Federation as the Chair, and shall attend Board meetings with a vote solely in the event of unavoidable absence of the Group Chair. <u>Deputy Chairs can serve a</u> <u>maximum of three (3) full Terms before a compulsory break of at least four (4) years. The</u> <u>Term of the Deputy Chair shall match the Term of the Chair</u>."
