We need to see this proposal in the Rules. It is important that a stand alone or EEF Series CSIO remains a Nations' Cup Event. We had this debate before.

NED NF

It states that all references to FEI Nations Cup will be corrected to Longines League of Nations. In all the meetings between stakeholders and the FEI it was said that the Longines League of Nations could be the only series as such but that all other events still could be held as Nations Cups although not a Longines Nations Cup. We presume that is still the case if this proposal is agreed upon?

If not, we oppose.

SUI NF

It is important that, in future, all team competitions at CSIOs continue to be called Nations Cups, regardless of whether they are part of a series or not, or whether they are at 3^* , 4^* or 5^* level.

After further internal review of Art. 200.8, the following wording is proposed and the same changes apply to Articles 300.1.3 and 316.1.3 of the Jumping Rules for Championships and Games.

For the avoidance of doubt, all references to CSI5* and CSIO5* Events in the paragraphs below (Art. 200.8) include CSI5*-W and CSIO5*-W Events.

CSI5* and CSIO5* Events are not permitted to clash with the FEI World Cup[™] Jumping Final or with the FEI Nations CupLongines League of Nations[™] Jumping Final. Events that are part of a Series may not clash or overlap with the FEI World Cup[™] Jumping Final.

From the Monday of the week of and all days during the World and Continental Jumping Championships for Seniors it is forbidden to host an FEI World Cup[™] Competition, a CSI4*, CSIO4*, CSI5* or a CSIO5* on the same Continent as the Championship.

There shall be no FEI World Cup[™] Competition (worldwide) 10 days prior to, all days during and seven days after the Jumping Events at the Olympic Games; there shall be no FEI World Cup[™] Competition 10 days prior to, all days during and seven days after the Jumping Events at the Pan-American Games on the same continent.

From the Monday of the week preceding and all days during the Jumping Events at the World Equestrian Games Championships for Seniors and the Olympic Games and the FEI World CupTM Jumping Final it is forbidden to host an FEI Nations CupLongines League of Nations TM Jumping Event (worldwide).

From the Monday of the week preceding and all days during the Continental Championship for Seniors it is forbidden to host an FEI Nations CupLongines League of Nations[™] Jumping</sup> Event on the same continent as the Championship.

From the Monday of the week preceding and all days during the Jumping Event of the Pan-American Games it is forbidden to host an FEI Nations CupLongines League of Nations[™] Jumping</sup> Event in the Americas.

From the Monday of the week preceding and all days during the Jumping Event of the Asian Games it is forbidden to host an FEI Nations CupLongines League of Nations[™] Jumping Event in Asia.

For the introduction of the Key Event Requirements (KER 13 – Adequate access to training/schooling), there was a need to bring some indication and clarity in the rule around warm-up arenas so that there is a correlation drawn between the size of it and the number of horses that can access it.

Proposed Wording on 28 June 2023

The number of horses allowed inside the schooling area must be directly related to the size of the arena. The Chief Steward has the authority to limit the number of horses based on the size of the arena and in consideration of safety measures.

We agree there is a need to bring some indication and clarity in the rule around warm-up arenas so that there is a correlation drawn between the size of the arena and the number of horses there. However, we think the proposed wording is too vague, and we propose a more precise indication of the number of horses per, for example, 10 m2.

The number of horses in the warm-up area depends on several factors and the Jumping Committee believes the proposed wording is a first step in the right direction and maintains the initial proposed wording however agreed to mention "warm-up area" instead of "schooling area" for more clarity.

The IJRC believes that a broader concept (going beyond just the relatively rare case of blood in the nostrils) is needed in order to give the Ground Jury the clear authority to take action where there are serious horse welfare concerns.

- A clear definition of the cases leading to elimination is required.
- During major events a previous Olympic medalist or top rider could act as support official to provide advice. This would create a decision-making panel so as not to entrust responsibility to just one individual.

Proposed Wording on 28 June 2023

The President of the Ground Jury (or in the absence of the President of the Ground Jury from the Ground Jury box, the Ground Jury Member designated by the President of the Ground Jury to take over the running of the Competition in their absence) may, in their sole discretion, ring the bell (or instruct another Ground Jury member to ring the bell) to eliminate an Athlete/Horse combination while a round is ongoing if the President of the Ground Jury (or their designee) decides that it would be contrary to the principles of horse welfare this would be in the best interest of the wellbeing and/or safety of the Horse and/or Athlete to allow the combination to continue the round.

The decision to eliminate is final and not subject to appeal or protest.

IJRC

The IJRC believes that a broader concept (going beyond just the relatively rare case of blood in the nostrils) is needed in order to give the Ground Jury the clear authority to take action where there are serious horse welfare concerns.

- Regarding a clear definition of the cases leading to elimination, the wording reviewed and the update proposed on 28 of June, should be applied.
- With regards to the request to appoint a previous Olympic medalist or top rider, during major events, to act as support to the officials, this is important also because of the impact of the consequences of an elimination, which would result in the elimination of the entire team.

Considering also that the decision to eliminate is final and not subject to appeal or protest, it seems appropriate and simple that the President of the Ground Jury is in contact even by telephone, with the appointed former rider.

This does not require an excessive delay in the decision process.

The Course Designer for CSIO1* or CSIO2* Events at which the Nations Cup Competition is built to the dimensions set forth in JRs Art. 264.3 for 3* Events or higher must be selected from the list of Level 3 Course Designers at least.

The total Penalties of the best three Athletes per team in the first round are added to the total Penalties of the best three Athletes per team in the second round.

9.2.1. In case of equality of Penalties for the first place, there will be a jump-off in which one Athlete per team will participate. The Chef d'Equipe determines which member of their team will participate in the jump-off. Any one of the four team members, respectively three team members if applicable, may take part in the jump-off.

The jump-off takes place against the clock over a minimum of six obstacles.

In case of equality of Penalties and time after the jump-off, the teams concerned will be placed equal first.

9.2.2. Teams with equality of total Penalties for other places <u>after the second</u> are placed according to the total Penalties of their best three Athletes in both rounds and the combined times of their best three Athletes in the second round. In case of equality of total Penalties and combined times in the second round, the teams concerned will be separated by the combined times of their three best Athletes in the first round.

10.2. The Nations Cup at CSIOCh and CSIOP Events is judged under Table A not against
the clock with a time allowed in both rounds. (For <u>The Nations Cup at</u> CSIOY and CSIOJ as
per paragraph 1.7 above.)Events is judged under Table A, both rounds against the clock.
10.3. For all CSIOY and CSIOJ, the classification of teams not taking part in the second
round is according to paragraph 9.1 abovebased on the total Penalties of the three best
Athletes of each team in the first round. Teams with equality of Penalties are placed
according to the combined Penalties and times of their best three Athletes.
The placing of teams after the second round is according to paragraph 9.2 and 9.2.2 above
decided as follows:-
10.3.1. In case of equality of Penalties for the first place, there will be a jump-off in which
all team Athletes may take part. The jump-off takes place against the clock over a minimum
of six obstacles. Classification of the teams in the jump-off is based on the total Penalties
of the three best Athletes of each team in the jump-of. Teams with equality of Penalties
are placed according to the combined Penalties and times of their best three athletes.
10.3.2. Teams with equality of total Penalties for other places after the second round are
placed according to the total Penalties of their best three Athletes in both rounds and the
combined times of their best three Athletes in the second round. In case of equality of total
Penalties and combined times in the second round, the teams concerned will be separated
by the combined times of their three best Athletes in the first round.
<u>10.4.</u> For all CSIOCh and CSIOP the classification of teams not taking part in the second
round is based on the total Penalties of the three best Athletes of each team in the first
round. Teams with equality of Penalties are placed equal. The starting order of teams in
the second round will be in the reverse order of the total Penalties in the first round of the
best three Athletes in each team. In case of equality of Penalties the teams will retain the
same starting order as in the first round. Placing of teams after the second round is
according to paragraph 9.2 and 9.2.2 abovedecided as follows:
<u>10.4.1. However, for all CSIOY, CSIOJ, CSIOCh and CSIOP, iI</u> n case of equality of Penalties
for the first place, there will be a jump <u>-</u> off in which all team Athletes may take part. The
jump-off takes place against the clock over a minimum of six obstacles. <u>Classification of</u>
the teams in the jump-off is based on the total Penalties of the three best Athletes of each

Explanation for Proposed Change

Article 276.1.4 (2 rounds and winning round) states that the course of the winning round must be a shortened course over obstacles of the first and/or second round. Thus no new obstacles are allowed.

In Article 276.2 (one round and winning round), there is nothing mentioned about the course of the winning round. If you do it strictly according to the rules, you have to use the same course in the winning round.

We suggest to precise in Art. 276.2 that the winning round must be over a shortened course and to add the option of having 2 new obstacles for both 276.1 and 276.2.

Athletes and Horses for whom Certificates of Capability have not been received will not be allowed to be entered for the Olympic Games or World or Continental Championship concerned.

9. Any and all "*hors concours*" participation provided for directly or indirectly in the present Annex and/or in any special Rules of the Jumping Discipline are in compliance with the permissible exceptions as per GRs Art. 117.6.

10. The report of the Foreign Judge must be sent to the FEI Jumping Director who in turn will send a copy to the Chair of the Jumping CommitteeDepartment. The NFs of the qualified Horses and Athletes will be informed by the FEI immediately after the qualification is confirmed.

The prices of air flights have increased enormously in the last year due to the increase in fuel prices and the fact that after the Covid many companies have reduced the number of flights and there are fewer options. In many non-European countries there are no top-level local officials, so the organizers are forced to invite some officials from Europe. For Organizing Committees, already forced in the last 2 years to a large increase in organizational costs (more costs for services veterinary, for services related to sanitary procedures, increase in the costs of all suppliers, increase in the transport costs of all materials, increase in the daily fee of all officials, increase in the prize money of the Ranking classes, increase in the minimum prize money for the categories/stars of the events, etc) the cost of the Business class has become unaffordable.

Explanation for Proposed Change

An increase of the per diem allowance for Officials between 25% - 108% is not a proportionate increase, especially because all travel expenses, shuttle transport, accommodation and meals are also increasing.

This significant increase causes a very high financial impact on the budget for tours having a large number of Officials.

The below regulation in Art. 6.2.1.5:

"For Events where more than one CSI or CSIO Event is organized, the minimum per diem to be offered must be according to the highest star level at that Event"

is not proportionate compared to the classes/ entry fees for Tour with several star levels. I.e., the situation at MET with the following 39 classes per week:

9 classes CSIYH* (23%)

18 classes CSI1* (46%)

12 classes CSI3* (31%)

A total of 69% of the classes per week are CSI1*/YH* category.

Therefore, it is not appropriate to pay for all Officials every day of the event the CSI3* per diem allowance.

Tours give many Officials the opportunity to work several weeks in a row.

Example MET: 21 weeks (147 days a year).

There should be room for a special agreement by mutual consent with Officials getting an offer for 21 complete weeks.

Beside this, it is necessary having an appropriate time frame getting new regulations in effect, to allow OCs adapting their budgets considering the high financial impact from these new rules.

There have been incidents (again) that at the entrance of the arena, due to loud music in the kick-off of a jump off, an athlete falls. If the athlete falls on the ground just before the entrance or just after, it gives a different way to solve this?

Even if an athlete is last in the class, a fall in the arena prior to starting should also still provide the possibility to start, after being checked for example using the same principle as with a fall in the warm-up.

Explanation for Proposed Change

CURRENT SITUATION

When an unforeseen incident happens during a course, the rider is stopped and needs to restart where he/she has been stopped after the bell has rung.

ISSUE

• Recently, some groups of activists have been intervening in the competition arena while a round is in progress on numerous occasions. This results in riders being stopped and having to leave the arena for quite some time. According to the rules, they have to restart their class where they were stopped.

• This means that riders have to restart eg at a triple combination, or a difficult wall,

• Is it fair (eg in outdoor events) to have combinations starting at a liverpool, the water jump...?

• From a horse welfare perspective and a horsemanship point of view this is not a good solution and needs to be reconsidered.

• The disadvantage that riders have because of such incidents is even made stronger by having them restart at a difficult fence.

ALTERNATIVE

Within the dressage rules, a similar "unforeseen" article is available for incidents during the Kur (eg music that stops) where the ground jury agrees with the rider where to restart the test. Marks given will not be changed (dressage rules article 420.2.2)

PROPOSAL

We have to reword the article 233 to make it more horse-friendly but at the same time guaranteeing the level playing field.

The idea should be to keep the faults that were incurred so far and have the combination restart where jury and rider agrees.

The responsibility lies with the rider and if disobediences are incurred when the restart is given, they will count. A fall will also result in elimination.

BEL NF

BEL NF asks the FEI to reconsider their advise and still propose this change to the General Assembly. We do not agree with the point of view that the rule has not proven to be problematic as the application of the existing rule has created situations resulting in unfair treatment from horse/athlete combinations needing to restart their course after a long waiting time on a fence that never is put at the beginning of a class (like a wall, a triple combination, ...). This is not fair from a horse welfare perspective and it is not creating a level playing field neither. Combinations that have been stopped during their round get double disadvantaged because of the current rule.

Even if the FEI Jumping Committee considers the rule as not proven to be problematic, we see our role as governing bodies to prevent problematic situations by modifying the rules where needed and appropriate instead of intervening after problematic situations might occur. Seen the fact that a similar rule is in place within dressage, it is logic we apply the same approach consistently across different disciplines.

As a result the BEL NF resubmits the proposed alternative wording.

BEL NF asks the FEI to reconsider their advise and still propose this change to the General Assembly. There are additional arguments to be taken into account to change the current rules.

- The split in results of TIME faults and OBSTACLE faults is indeed an improvement
- For the lower level classes however, where disobediences occur more frequently then at the highest level sport, the current rule setting creates completely different results. As the time faults increase rapidly, this means for example that an athlete having one refusal resulting in additional time faults is ranked often after combinations with 3 or 4 jumping faults. This is not logic.
- As for a disobedience with displacement a time correction of only 6 seconds is added, we notice that in some cases horses are pushed into fences after a disobedience to reduce the time penalties and limit the number of seconds to this time correction instead of taking the time to just restart after a normal disobedience. This is a side effect of the rule change that is not supporting horse welfare.
- As time faults in a normal class are added up quickly now, we get results like 25 or more penalties, which is not a good thing.
- The rule change towards 1 point per second is interesting for higher classes like Longines Ranking Classes, Grand Prix, Nations Cups or Championships but has negative impact on the results in lower level classes and therefor creating unfair situations that need correction.

- Swiss inflation on PM set in CH.
- The proportion between the minimum and maximum entry fee and the minimum and maximum PM. Most organizers (1*-2*-3*-4*) apply the maximum Entry Fee but the minimum PM.
- Proportionality between number of starters and PM.
- That the exchange rate for PMs is set by the FEI in January, while entries fee are paid considering the exchange rate of the day set by the organizer.

The increase of the entry fee and of the costs, which are already expensive, will become unaffordable for some countries or the whole of Easter Europe, where the sport is currently undergoing promising development.

A consultation is necessary as the following indexes have to be taken into account:

- Inflation indexes.
- Increase of cost-of-living indexes.

Conversion rates as the exchange rate for PMs is set by the FEI in January, while entries fee are paid considering the exchange rate of the day set by the organizer.

Explanation for Proposed Change

 5^* events that have no entry fee are a minority. In 2022 there were approx 76 5^* events (CSIO, CSI, CSIW in Europe and America. All CSIO, CSIW and 5^* events in America charge an entry fee and are around 60% of the events.

Among the approximately 30 events that cannot receive entry fees, there are 16 events of the Global Champions Tour and Global Champions League circuit. The other 14 are "independent" 5* events or that are not part of any circuit.

With the calendar structure of recent years, only some 5^* event organizers are penalized by not being able to ask for an entry fee from riders.

We believe that the payment of an entry fee must be standardized for all 5* events with the same amount.

We absolutely agree to the proposal of the SUI NF for reasons of clarity.

Another aspect needs to be tackled as well that has become an issue because more and more OCs schedule a mixed competition for youth age categories, a CSIJYU25.

The current definition in this article allows a 16-year-old Athlete to compete as a Junior, Young Rider, U25. But a provision in Annex XI Rules for Pony Riders, Article 7 restricts these rights: "... Pony Riders may not take part in Competitions for Pony Riders and in Competitions for Young Riders or in U25 Competitions at the same venue during the same week; any Pony Rider who takes part in Pony Competitions and in Competitions for Young Riders or in U25 Competitions at the same week will be disqualified from both Events."

Thus, as soon as a 16-year-old rider is entered for a pony competition at the same event as the CSIJYU25 – which has very often been scheduled as such lately -, he/she is considered a Pony Rider and therefore may not compete in any of the classes with a Horse (unless there is a free place in the Juniors category which is hardly ever the case).

We ask that Athletes of the appropriate age must be allowed to compete with a Horse according to the Athlete's age and not according to the age category they are put into. If Athletes are 16 years old, they have the right age for P, J, Y, U25. But why should a 16-year-old not be allowed to ride a Pony and a Horse on the same show? This should be possible. If we want to maintain the Pony Riders' interest in the sport, we must give them every possibility of making their transition to the next level, and we must not wait for the next full revision in 2025 because then an alteration would not be in force before 2026.

In Annex XI Rules for Pony Riders, Article 7

"However, Pony Riders may not take part in Competitions for Pony Riders and in Competitions for Young Riders or in U25 Competitions at the same venue during the same week; any Pony Rider who takes part in Pony Competitions and in Competitions for Young Riders or in U25 Competitions at the same venue during the same week will be disqualified from both Events."

Reduce the minimum age of Horses for U25 and Young Riders to six years, providing that the maximum height does not exceed 1.40 m.

Also see: Age of Athletes and Horses according to the Event's Category in the Schedule of every International event.

It does not make sense, that Junior riders may ride six year old horses in CSI/O J classes (which may be up to 1.40m) but Young Riders and U25 riders may not ride a six year old horse in the Y / U25 classes which may be as low as 1.20m. To protect the 6 years old horses we suggest to limit the height for that age group.

ANNEX XI – RULES FOR PONY RIDERS Art. 4 – DEFINITION OF A PONY

Explanation for Proposed Change

Although the new rule that ponies are no longer allowed in CSI1* and CSI2* competitions was implemented on 1.1.2022, it has shown its consequences during this year. The pony sport must be supported and especially for families with both horses and ponies it was much easier, cheaper and feasible to compete with both at the same event. These competing possibilities are missed a lot and make it much more difficult for those pony riders to get the relevant experience.

Furthermore, the riders basically already have many days of absence from school to be able to participate in (international) events. The days to be excused from school are usually limited. This in turn suggests that riders should have as many opportunities to compete as possible to make the most out of the events and not have to leave one weekend with the pony, and the next with the horse. Education is immensely important and should not be by the sport. We need to get closer to the riders and families again.

Athletes may compete in the U25 Category from the beginning of the calendar year in which they reach the age of 16 until the end of the calendar year in which they reach the age of 25. From the year in which they reach their 14th birthday until the end of the year in which they reach their 15th birthday, Athletes may participate in U25 Competitions providing the height of obstacles in the initial round does not exceed 1.40 m (see JRs Art. 255.2.2).

3.2 For Young Rider's age, please refer to the FEI General Regulations Appendix A – Definitions. An Athlete may compete as a Young Rider from the beginning of the calendar year in which they reach the age of 16 until the end of the calendar year in which they reach the age of 21.

3.3 For Junior Rider's age, please refer to the FEI General Regulations Appendix A – Definitions. An Athlete may compete as a Junior from the beginning of the calendar year

in which they reach the age of 14 until the end of the year in which they reach the age of 18.

3.1 An Athlete may compete as a Pony Rider from the beginning of the calendar year in which they reach the age of 12 until the end of the year in which they reach the age of 16. For Pony Rider's age, please refer to the FEI General Regulations Appendix A – Definitions.

3.1 An Athlete may compete in the Children's Category from the beginning of the calendar year in which they reach the age of 12 until the end of the calendar year in which they reach the age of 14. For Children Riders' age, please refer to the FEI General Regulations Appendix A – Definitions.
