### **Education & Officials - 2021 CES Assessments**

As of 16 December 2020, the 2021 CES Assessments will be accessible. Separate enrolment notifications will be sent for each CES Assessment directly to FEI Officials via FEI Campus. This means that depending on the function and discipline, several CES Assessments might have to be taken by Officials.

Group A: Officials currently up-to-date with their In-Person Maintenance Cycle are invited to take the CES Assessment on FEI Campus from 16 December 2020 to 15 December 2021. Note that to officiate at events taking place after 31 March of each year, Officials must have passed the CES Assessment.

- If passed, the function will be extended to 31 March 2022.
- If not passed, the function will be "On Hold" not being allowed to officiate until an In-Person Maintenance Course (CES) is attended before 15 December 2021.
- If the CES Assessment 2021 is not taken by 15 December 2021, the function will be closed.

Group B: Officials who have not done an In-Person Maintenance Course since 31 December 2016, have to take part in an In-Person Maintenance Course with assessment before 15 December 2021 and can continue to officiate in their current status until that date.

If an In-Person Maintenance Course with assessment is not attended by 15 December 2021, the function will be closed.

### **Dressage Judges Advisory Group (JAG)**

Please note a Judges Advisory Group (JAG) for Dressage has been appointed by the FEI Dressage Committee, in accordance with the recommendations of the Dressage Judging Working Group. As part of their job description, the JAG will embed the role of the Judge General and the Dressage Education working group, while the Judges Supervisory panel (JSP) will continue to act at Championships, Games and Finals as before.

Both groups will work closely with the Dressage Committee on all matters related to Judging. The members of the JAG are Katrina Wüst (GER) (Spokesperson), Stephen Clarke (GBR), Hans-Christian Matthiesen (DEN), George Williams (USA) and David Hunt (GBR) (liaison with the JSP).

### **Eventing Dressage Tests**

The 2021 Eventing Dressage tests are now available on Inside.FEI.org. Please note:

- The CCI2\* Dressage tests A and B have been slightly modified and will be effective as
  of 1 January 2021.
- A new 2021 CCI3\* B test is now available replacing the 2020 CCI3\*B test and will be effective as of 1 January 2021.
- A new 2021 CCI1\* Dressage test will be published mid-January 2021 on the same webpage replacing the current 2020 CCI1\* Dressage test.
- · All other tests remain unchanged.

### **Eventing Risk Management Programme - FEI Approved Frangible Devices**

As of 1 January 2021, the compulsory use of frangible devices on certain types of fences has been extended to all levels as per Article 547.2.4 of the FEI Eventing Rules.

The FEI Register of Products having met the Updated Standard for frangible/deformable Cross Country fences Version 2, has been updated on **Inside.FEI.org**.


