

**PROPOSALS FOR RULES CHANGES OF  
PARA DRESSAGE RULES 2023**

Dear National Federations,

Please find below a summary of the proposed changes to the Para Dressage Rules together with the corresponding explanations, the comments received as well as the reasoning for accepting or not accepting each proposal.

*Note:* in the change proposed, the Dressage tests are renamed for more clarity and to reflect the progressive levels in the competition structure. Upon approval of the 2023 Para Dressage rules, which include the new proposed Dressage test names, all documents which refer to the Para Dressage Tests will be updated accordingly (for example the PG qualification system and requirements, the FEI World Ranking Rules, the Paralympic Ranking Rules, etc...).

The PETC proposed to change the formats for CPEDIs to show more progression through the levels. This was both to encourage Athletes to start at an appropriate level to develop the lower levels of events, as well as to make lower level Events more attractive for OCs to host.

Each level of Event would have its own appropriate level of Para Dressage Tests. Team Competitions would only take place at CPEDI3\* and above. Freestyles would be optional in CPEDI1\* and CPEDI2\* (both for OCs to schedule, and for Athletes to compete in).

3.1 Events must comprise of two (2) or three (3) Individual Competitions for each of the five (5) Grades as follows:

5.2 Individual Results are produced for each Competition.

5.3 The Team Competition results are produced as follows:

5.3.1 No Country may enter more than one (1) team. The teams must consist of a maximum of four (4) and a minimum of three (3) Athletes of the same nationality, declared prior to the Competition. A Grade I, Grade II or Grade III Athlete must be included in each team, riding the relevant Test. The three (3) highest placed Athletes,

determined by their percentage scores in the Para Grand Prix and the Para Grand Prix Special combined, shall be totalled to determine the final team placings. A team may not include more than two (2) Athletes from any one (1) Grade.

#### Comments received by 24 August 2022

**EEF** - We see the rationale behind this proposed change but are concerned about the feasibility of its implementation in the current realities with the current number of Para-Dressage riders and OCs willing to host 1\*/2\* events.

**GBR** - This rule is written in relation to a CPEDI3\* - our question is whether this relates to a CPEDI3\* being a Nations Cup event in 2023? If not, is there an opportunity to create more competitive exposure for athletes at this level, by permitting a nation to enter more than one team. Where you have individual athletes entering from different Nations, they could also potentially be combined to create a team to represent a region instead?

This may form part of a wider review of the competition format.

**NOR** - Regarding description of the third competition this should be named as Freestyle final, and medal should be added, similar to the other two competition days.

#### FEI feedback

The PETC thanked the EEF, The GBR NF and the NOR NF for their comments.

EEF/GER NF: The PETC is of the opinion that it might help the development of the discipline. CPED1\* and CPEDI2\* events can be added alongside existing CPEDI3\* without any additional cost. As previously explained, the PETC would like to offer more opportunities to Athletes to progress in their International career by giving them qualification steps. Based on previous experience in disciplines where similar star levels were also introduced, the outcome is that is helped quite significantly the growth of the sport worldwide.

GBR NF: this will be reviewed in 2023 and entering more than one Team per NF is possible in other disciplines (eg Vaulting) and such solution could be considered.

NOR NF: the PED TC believes the wording is clear as stated, so no change is proposed

No Country may enter more than one (1) team. The teams must consist of a maximum of four (4) and a minimum of three (3) Athletes of the same nationality, declared prior to the Competition. A Grade I, Grade II or Grade III Athlete must be included in each team, riding the relevant Test. The three (3) highest placed Athletes, determined by their percentage scores in the Para Grand Prix A and the Para Grand Prix B combined, shall be totalled to determine the final team placings. A team may not include more than two (2) Athletes from any one (1) Grade.

**Article No. 8421.2.4.1 – Dressage Tests / Freestyle to music (2023 Art 8402.3/8402.4)**

#### Explanation for Proposed Change

##### NF Explanation

8421.2.4.1 – Remove the mandatory requirement for 1\* & 2\* Freestyle tests. Often harder than Novice A tests through the mandatory movements.

Make Freestyle an optional requirement for athletes at 1&2\* level, with no requirement to produce a certificate. Athletes can declare their intention to compete in the Freestyle on entry or arrival. Or produce a Freestyle test with different mandatory movements that reflect the technical ability of Horse and rider at this stage of their competitive journey.

##### NF Proposal

**8421.2.4.1** – At CPEDI3\* level all Levels of Events it is mandatory to participate if qualified, unless otherwise supported by a Veterinary or Doctor's Certificate. At a CPEDI 1\* and 2\* it is not mandatory to compete in the Freestyle, but the athlete must declare their intention

to compete on entry or arrival. An Athlete who does not participate without legitimate reasons in a Competition where the participation is mandatory, will lose their placing and prize money from the previous Competition(s) in the Event and will be disqualified from the Event.

**FEI Feedback**

With the new Competition formats, the PETC have decided that Freestyles in CPEDI1\* and CPEDI2\* would be optional, both in scheduling and for the Athletes to participate.

**Proposed Wording on 6 July 2022****Art 8404.3.1**

At CPEDI 1\* and 2\*, all Athletes may compete in the Freestyle, when scheduled. Athletes must declare their intention to compete on entry.

<b>Explanation for Proposed Change</b>								
The current Para Dressage Tests referred to the Competition they were used for, which was difficult to then use the test for different results (eg combining two tests to have Individual results). The PETC decided, with support from stakeholders in a Test Names survey, to change the names to reflect the Levels of Events. The test names would no longer refer to the Competition, and so different formats could be created without confusion. Competition names or Test names were changed throughout the Rules.

<b>NED</b> - We do not see the added value to change the names of the Team and Individual Tests and Freestyle to Para Grand Prix, Grand Prix Special and Para Grand Prix Freestyle and adding Intermediate A, B and Freestyle. One of our concerns is that implementing this will lead to discussion and additional training will be needed for stewards and judges.								
<b>BEL</b> - Create confusion with dressage discipline and does not create added value --> Keep current names								
<b>FEI feedback</b>								
The PETC thanked the NED NF and the BEL NF for their comments.								
The PETC would like to emphasise that based on the survey that has been conducted earlier this year, the majority of National Federations were in favour to rename the current tests as proposed above. The name of the tests should not reflect the name of the competition to avoid confusion.								
Due to that and based on the comments received, the PETC proposed to change the names of the test to Para Grand Prix A and Para Grand Prix B, which follows the same logics as the names of the Para Novice and Para Intermediate tests and then will be proper to Para Dressage. In Dressage, the Grand Prix Special is primarily focusing on the transitions and the Para Grand Prix B in Para Dressage won't have the same focus.

<b>8404 Qualification Criteria</b>
<b>Explanation for Proposed Change</b>
<p>The PETC propose to introduce a Qualification criteria for CPEDI3* and above. At the FEI Sports Forum two proposals were put forward, one for qualification at all levels and one just for CPEDI3*. The feedback was that qualification at all levels would currently be too difficult for developing nations.</p> <p>The Qualification criteria would be a document published on the FEI website, and approved by the FEI Board. The proposal for 2023 would be that Athletes should gain 60% at a CPEDI2* (not in the freestyle) to qualify to compete in CPEDI3*. The Qualification would be to the Athlete, not to the combination.</p>
<b>Proposed Wording on 6 July 2022</b>
<ol style="list-style-type: none"> <li>Athletes are required to qualify for CPEDI3*s, FEI World and Continental Championships, the Paralympic Games and any other Events where qualification is required.</li> <li>Qualification criteria and Minimum Eligibility Requirements are published on the FEI Website.</li> </ol>
<b>Comments received by 24 August 2022</b>
<p><b>ITA</b> - We are concerned of feasibility of introducing a qualification system from one level to the other in Para-Dressage. We feel that there are not enough 2* events and athletes to warrant such a system.</p> <p><b>SWE</b> - The proposal for an Athlete to qualify for CPEDI3* at CPEDI2* events already from 2023 seems for us a bit too early as there is almost no CPEDI2* events organised. Such criteria can only be implemented when there is enough CPEDI 2* events to qualify at.</p> <p><u>Proposed wording:</u></p> <ol style="list-style-type: none"> <li>Athletes are required to qualify for FEI World and Continental Championships, the Paralympic Games and any other Competitions Events where qualification is required.</li> </ol>

<b>8407 Arena Specifications, Publicity on Dressage Fence, and Practice Arenas</b>



<b>Explanation for Proposed Change</b>	
The wording for Arena Specifications, Publicity on Dressage Fence..., Judges Huts, Pause, and Practice arenas, were all updated to reflect the FEI Dressage Rules where necessary. This included aligning distance measurements and including the text for Footing requirements.	
<b>Proposed Wording on 6 July 2022</b>	
<b>1.</b>	<b>Approval</b>
1.1	At Paralympic Games, Regional Games, and FEI Championships the Competition arena has to be checked and approved by the Foreign Technical Delegate in order for the Competition to start.
1.2	At all other International Events, the Competition arena has to be checked and approved by the President of the Ground Jury in order for the Competition to start.
<b>2.</b>	<b>Arena Specifications</b>
2.1	Athletes in Grades I-III compete in an arena twenty meters by forty meters (20mx40m). Athletes in Grade IV-V compete in an arena twenty meters by sixty meters (20mx60m).
2.2	The arena, flat and level, must be sixty (60) meters long and twenty (20) meters wide. The difference in elevation across the diagonal or along the length of the arena shall in no case exceed sixty centimetres (60cm). The difference in elevation along the short side of the arena shall in no case be more than twenty centimetres (20cm). The arena must be predominantly of sand. The measurements above are for the interior of the enclosure, which must be separated from the public by a distance of not less than ten (10) meters. For indoor Competitions the minimum distance should in principle be two (2) meters. The enclosure itself should consist of a low white fence (rails which must not be solid), about thirty centimetres (30cm) high. The part of the fence at A should be easy to remove, to let the Athletes in and out of the arena and must be kept closed during each Athlete's performance and between tests, until the Judge at C gives the starting signal. The width of the entrance must be at least two metres (2m).The rails of the fence should be such as to prevent the Horse's hooves from entering. The rails may not contain any metal components. Refer to Annex 2 for details on arena.
2.3	An arena of forty (40) meters long and twenty (20) meters wide must also be provided for Para Dressage Grade I, Grade II, and Grade III Athletes.
<b>3.</b>	<b>Publicity on Dressage Fence and Judges Huts/Tables</b>
3.1	The FEI owns the sole right to publicity on the Dressage arena fence for all FEI Championships and FEI named Series. For these Events, the OCs may acquire publicity space from the FEI only by previous agreement, except for on the Dressage letters and their holders, where publicity is never allowed.
3.2	For all other International Events, OCs are highly encouraged to keep the Dressage arena fence free of publicity and to use extra publicity boards instead as per separately published recommendations from the FEI.
3.3	Publicity may only be on the inside of the fence, in black only and must, with the exception of A, leave at least one metre fifty (1.5 m) free of publicity on either side of the arena letters. The short side at M, C, H must be completely free of publicity. There must be at least 3 meters (3m) free of advertising on either side of B and E. A maximum of forty four (44) meters of publicity on the rails is accordingly permitted. The publicity must be positioned in a regular manner and each long side should reflect the other exactly.

- 3.4 The height of the sponsor brand/logo must not exceed twenty centimetres (20 cm) and the publicity must be fixed level with the top of the arena fence. Publicity may only be placed on the inside of the arena fence and any requirements in terms of agreements between the FEI and broadcasters as may be in force, must be respected.
- 3.5 Any publicity applied on the fence must previously be approved by the President of the Ground Jury/Foreign Technical Delegate before the start of the Competition. Any publicity at the front of the Judges huts may have a maximum dimension of 2m<sup>2</sup>.
- 3.6 In accordance with the above stated positioning of publicity, it is always permissible to place the name and/or logo of the FEI approved Event on the Dressage. For example: CPEDI3\* Hartpury
- 3.7 OCs who violate these Rules will be fined by the FEI as appropriate under these Rules and the FEI GRs and/or may lose the CPEDI status of their Event.
4. **Letters** The letters outside the enclosure should be placed about fifty centimetres (50cm) from the fence and clearly marked. It is compulsory to place a marker on the fence itself, level with and in addition to the letter concerned. Publicity is not allowed on letters or on letter holders. Letters should also be visible for the public.
5. **Placing of Judges.** When five (5) Judges are used, three (3) Judges must be placed along the short side, on the outside of and a maximum of five meters (5 m), minimum of three meters (3 m) from the arena at outdoor Competitions and preferably a minimum of two meters (2 m) at indoor Competitions; the Judge at C on the prolongation of the centre line, the two (2) others (M and H) two meters fifty (2.50 m) from and on the inside of the prolongation of the long sides. The two (2) Side-Judges (B and E) must be placed on the outside of and a maximum of five meters (5 m), minimum three meters (3 m) from the arena at B and E respectively; at indoor Competitions preferably a minimum of two meters (2 m). When three (3) Judges are used one (1) should sit on the long side. The President of the Ground Jury allocates the Ground Jury for each Competition and decides on the placing of the Judges.
6. **Judges' hut.** A separate hut or platform must be provided for each Judge. It must be raised not less than fifty centimetres (50cm) above the ground, in order to give the Judges a good view of the arena. The booth/hut must be large enough to accommodate four (4) persons.. Judges' huts should provide good views of the entire arena. For FEI Championships and Games, each Judges hut must be a Judges Signalling System, allowing each judge to discreetly inform the C-Judge in case of blood, lameness, error of course or equipment. A Judges Signalling button is optional for other Events.
- 6.1 The OC must ensure that the Judges' huts provide shelter, are suitably heated or cooled depending on weather conditions.
- 6.2 Only officiating people (to include officials fulfilling promotion requirements) are allowed in the Judges' huts. Any exceptions must have the prior approval of the President of the Ground Jury and must be included in the Foreign Judge report. No media nor recording equipment are allowed in the Judges' hut.
7. **Pause:** It is recommended to make a pause of about fifteen (15) minutes after every two (2) hours, to reconstitute the surface of the ground.
8. **Footing:** as advised in the [FEI Footing Standard](#).

The PETC proposed to remove the minimum number of Invitations for CPEDI1* and CPEDI2*. They also proposed to include guidelines for who should be invited per NF for Championships, and the required expenses and privileges for those invited.
<b>Proposed Wording on 6 July 2022</b>

**ARTICLE 8408 INVITATIONS**

1. The Draft Schedule must include a list of National Federations invited to the Event and Invitations must be extended through the respective NF.
2. Invitations for CPEDI3\* shall be extended to a minimum of six (6) NFs, including host NF.
- 2.1 Teams: An NF may enter one (1) Team. Composition of Teams.
- 3 The following persons are invited per NF at FEI Championships:
  - One (1) Chef d'Equipe
  - One (1) National trainer
  - One (1) Veterinarian
  - One (1) Groom per Horse
  - One (1) support personnel for NFs bringing Individual Athletes and two (2) support personal for NFs bringing a Team.

**GBR** - We commend the FEI on the positive action of the provision of more funded accreditation places at Championships. Whilst ensuring that the overall number of paid accreditation spaces available to NF's (at their own cost) allows for appropriate provision for their athlete and equine support needs, this change will enable us to provide opportunities for horse owners and recognise their invaluable contribution. We recognise the need to lobby our NPC for additional provision for Paralympic Games and request that the FEI makes similar representation in support to the IPC.

This is a unique situation for Paralympic athletes, who see their Olympic counterparts able to fully acknowledge their owners in the Games environment, due to the flexibility offered within a three-discipline accreditation matrix.

We are currently unable to replicate this at Para level, due to the requirements for athlete personal support (carers) and equine support inevitably restricting numbers of accreditation spaces available.

Proposed wording:

**Amend typo in point 3 – ‘support personnel’, not ‘personal’**

One (1) support personnel for NFs bringing Individual Athletes and two (2) support ~~Personal~~ personnel for NFs bringing a Team.

**NOR** - We do not support the proposed rule change regarding collective marks, due to the importance the collective marks have on giving the rider an indication and feedback, both on horse qualities, and riders skills and equestrian feel. If there has to be a change, we think it should at least be two collective marks: One for horse qualities and one for the rider's performance and skills. --> We suggest looking to the proposal regarding this matter in dressage from GER, GBR and IDTC, and adapt the wording to para-dressage.

- 1.1 When an Athlete makes an “error of course” (takes the wrong turn, omits a movement, etc.) the Judge at C warns them, by sounding the bell. The Judge shows the Athlete, if necessary, the point at which they must take up the Test again and the next movement to be executed, then leaves them to continue on their own. However, in some cases when, although the Athlete makes an “error of the course”, the sounding of the bell would unnecessarily impede the fluency of the performance - for instance if the Athlete makes a transition from Medium trot to Working trot at E instead of at K, it is up to the Judge at C to decide whether to sound the bell or not. If an Athlete makes an error of course/Test whilst executing a movement which is to be repeated later in the Test, the Judge at C should, in the interests of the Athlete, ring the bell as above and put the Athlete right. Marks will be deducted for the error by each Judge.
- 1.2 However, if the bell is not sounded at an error of course and the test requires the same movement to be repeated and the Athlete again makes the same error, the Athlete is only penalised once.
- 1.3 The decision as to whether or not an error of course has been made will be at the sole discretion of the Judge at C. The other Judges’ scores will be adapted accordingly.
- 2. Error of the Test/Execution**
- 2.1 When an Athlete makes an “error of the Test” they must be penalised as for an “error of course”. In principle an Athlete is not allowed to repeat a movement of the Test unless the Judge at C decides on an error of course (sounds the bell).

#### 1. Saddle

A well fitting, well maintained saddle and a girth, suitable to the Horse and Athlete shall be used. Any modification or adaptation to a saddle must ensure the Athlete's safety and must not affect the welfare of the Horse, especially regarding size, shape and weight.

1.4 Saddle pads should be white or off white. Contrast colouring and piping is allowed. Striped or multi-coloured saddle pads are not permitted. Plain or national saddlecloths may be used. See Article 135 of the FEI GRs, regarding Advertising and Publicity on Athletes and Horses.

2.5 A rein is a continuous, uninterrupted strap or line from the bridle bit to the hand. Each bit must be attached to a separate rein and reins may only be attached to the bit so that the reins can freely glide. Reins must not be made of rope material.

2.9 Any piece of tack that impairs the ears to move freely is forbidden.

3. Snaffle, Bridoon and curb bits must have a smooth surface. Twisted and wire bits are prohibited. Bits must be made of metal, durable plastic, flexible rubber or synthetic material. Bits may be covered with rubber/latex.

#### 4 Additional Items

4.1 False tails/tail extensions are permitted. False tails may not contain any metal parts, (except for hooks and eyelets), or extra added weight. Random checks will be conducted and contravening this rule will entail a Yellow Warning Card and Elimination.

4.2 Ear hoods are permitted for all Events, and may also provide noise reduction. However, ear hoods must not cover the Horse's eyes and ear plugs are not permitted. The ear hoods should be discreet in colour and design. Ear hoods may not be attached to the noseband. Ear plugs on Horses are forbidden but are allowed at prize giving ceremonies only for safety reasons. Random checks will be conducted and contravening this rule will entail a Yellow Warning Card and Elimination.

4.3 Any artificial decoration of the Horse is not allowed. It is not allowed to paint any part of the Horse's body nor is it allowed to obscure an existing wound or injury. Contravening this rule will entail a Yellow Warning Card and Elimination.

4.4 It is strictly forbidden to use any type of substance (like "marshmallow fluff", shaving cream etc) around the Horse's mouth to imitate foaming. Contravening this rule will entail a Yellow Warning Card and Elimination.

4.5 Gadgets. Martingales, bit guards, and kind of gadgets (such as bearing, side, running or balancing reins, nasal strips etc.) and any form of blinkers that interfere with the Horse's vision are, under penalty of elimination, strictly forbidden during training, warm-up and Competitions.

6. Each Judge must be assisted by a scribe who speaks and writes the same official language.
7. The Judge at C may decide if they wish to be assisted, in addition to the scribe, by a special assistant, whose task is to follow the progress of the Test, to inform the President of Ground Jury of any "error of the Course" and/or "error of the Test".
8. Level 2, Level 3 and Level 4 Judges may never act as secretaries or assistants to the President or any other member of a Ground Jury at International Para- Equestrian Dressage Events. Level 2 Judges may, however, sit in with higher level officiating Judges if they give their permission.
9. The President or the FEI Foreign Judge must arrive in time for the Horse Inspection. At Championships and Games it is compulsory that the Ground Jury should meet prior to the first Competition, this is recommended at CPEDI3\*s and below.
10. At any Event a Judge may not be called upon to judge more than forty-five (45) Athletes a day.
11. Where possible it is preferred that the same Ground Jury should judge each of the separate tests in the Team Competition (all Grades) to ensure consistent results. The same Ground Jury or with changes, may judge the other Competitions.
12. No Judge may officiate at an Event if their duties will involve a conflict of interest (see FEI GRs). For full details please refer to Annex VII Codex for Para Dressage Judges.
13. FEI Para Dressage Judges may not officiate at Senior Competitions and also compete internationally on the same continent within the same calendar year. They must declare to the FEI via their NF by 1st January each year whether they wish to judge or compete during that particular year.
- 14. President of the Ground Jury**
  - 14.1 The President of the Ground Jury allocates the Ground Jury members for each Competition and decides on the placing of the Judges.
- 15. Foreign Judge**
  - At CPEDIs the Foreign Judge acts on behalf of the FEI to ensure Competitions are carried out according to the FEI rules and comply with the approved FEI Schedule. The Foreign Judge will be identified in the Schedule and will be required to complete a Foreign Judge's Report. The Foreign Judge must be at least an FEI L3 Judge.

**BEL** - This change to an L rating system would be both divisive and disruptive and offers no benefits. Although this may seem a trivial issue it has important implications. The use of STARS \* is universally recognized worldwide (regardless of language) as a descriptor of quality, importance or expertise. Thus it has become a highly meaningful and an important marketing tool and indicator of status influencing all stakeholders, riders, judges, trainers and organizers plus spectators. The L descriptor carries no connotation nor context. 5\* connotes nec plus ultra universally, L4 suggests nothing how many L's are there? Using the STAR rating is also consistent with the way competitions are described, 1\* thru 5\*. The FEI's rationale for this change is to be consistent with the General Regulation Chapter VII Article 145- Judge point 3. Unless the Sport Rules provide otherwise, there shall be four (4) levels of Judges. The necessary qualifications for each Level are set forth in the Education System for each Discipline. This rationale is misleading. The above regulation stipulates NO specific descriptor for the 4 levels and also provides flexibility for the disciplines if they so please. Therefore, there is no requirement to change any descriptor. --> Keep current names (3\*, 4\* and 5\*)

**NOR** - We agree in the rational that there is a harmonisation across the disciplines regarding education and categorisation of judges. We see no reason to rename categories of judges, and suggest to keep the star rating of the. It is important that the categorisation of judges is the same for para-dressage as for dressage.

#### FEI feedback

The PETC thanked the BEL NF and the NOR NF for their comments.

The PETC supports to change from star level to level but if Dressage retain the star level naming, Para Dressage should align with Dressage. The FEI Board had agreed in June that Levels shall be used but that the L4/5\* reference could be used in all working documents.

The current ruling does not cover warm up arenas and we would not support this inclusion. The warm-up arena should be a free space for athletes and coaches to prepare their Horses effectively and appropriately, as they would at home, relative to their Horse's ability and training. However, this clarity must be offered for officials present at the Competition.

**NF Proposal**

**2.4.11.** Piaffe and Passage may not be shown intentionally by Athletes at any time while riding their Horse in the Competition arena prior, during and immediately after the Test. **This does not include warm up areas.** Contravening this rule may result in a Warning Card.

**FEI Feedback**

Please see the comment for Article 8416.2.5 above, which covers not allowed movements in the Field of Play.

Athletes riding in the warm-up arena have a responsibility for themselves. Stewards will take charge in the case of any dangerous riding (eg in case it seems an Athlete is in danger with their riding), but there are not restrictions on the movements that can be ridden in the warm-up arenas. The PETC did not agree to make any changes to the text, as the article on movements around the Field of play were clear enough.

<b>NF Explanation</b> It appears that bleeding from one or two nostrils is not covered in current regulations. Nose blood can occur from bleeding in upper and/or lower airways (in racing horses not unusual with even lung bleeding, Exercise Induced Pulmonary Haemorrhage, EIPH, usually after exercise).  To distinguish from a suspected minor bleeding due to a small laceration of a nostril, it should be checked by an FEI Veterinarian after the ride.  Nose blood should be a reason for elimination because of the impact on Horse welfare, but also for general perception, i.e., Social License to Operate (SLO).
<b>NF Proposal</b> <b>11.4 Bleeding:</b>

If the Judge at C suspects fresh blood anywhere on the Horse during the Test, they will stop the Horse to check for blood. If the Horse shows fresh blood, it will be Eliminated. The Elimination is final. If the Judge through examination clarifies that the Horse has no fresh blood, the Horse may resume and finish its Test.

If the FEI Steward discovers fresh blood in the Horse's mouth, **nostril** or in the area of the spurs during the equipment check at the end of the Test (Art. 8430.12), they must inform the Judge at C, who will Eliminate the Horse and the Athlete.

If the FEI Steward discovers fresh blood anywhere else on the Horse's body (i.e. other than the Horse's mouth, **nostril** or in the area of the spurs) during the check at the end of the test, the Athlete/Horse combination is not automatically eliminated. The FEI Steward shall inform the Judge at C and an FEI Veterinarian must be called to examine the Horse and advise the Judge at C whether the Horse is fit to continue in following Competition(s) in the Event. The Judge at C will take a decision on the Horse's fitness to continue, based on the FEI Veterinarian's advice. If the Judge at C decides the Horse is not fit to continue, the Horse will not be permitted to take part in any further Competition(s) or tests at the event but the result(s) obtained by the Athlete/Horse combination in any Competition(s) or tests already completed shall stand. If the Horse is Eliminated pursuant to the above, or if the Horse is injured during the Test and starts bleeding after finishing the Test, it should be examined by an FEI Veterinarian prior to the next Competition to determine if it is fit to continue in the Event the following day(s). The decision of the President of the Ground Jury, based on the recommendation of the FEI Veterinarian, is not subject to appeal.

**8454** - Prize money for Para Dressage was raised at the EEF Para Dressage meeting due to the inequality that exists with able bodied Competition, which does not reflect well on the sport. Suggestions were put forward, including a proposal that a small percentage of sponsorship for able bodied dressage Competition should be allocated to a para fund.

Whilst we appreciate challenges of the organisers and do not want to introduce further barriers, from an athlete perspective the sport of Para Dressage is just as costly, if not more so, than for able bodied Competition. As such, athletes would like to see a required inclusion of prize money at 3\* level. This would have to be a realistic and modest amount initially, but something that reflects the principle of equality for all athletes, whether Para or able bodied.

The PETC agreed that the issue of prize money was one that needed to be examined, but they felt that imposing it on the OCs of CPEDI3\*s was too early, as it cannot yet be imposed at Championships and Games. Polyamide a rubber-based material that is designed for more comfort for Horse and rider. Must have the ability to flex in all directions to show that the spur itself does not snap. We fully support that plastic-based material that can snap are not permitted, however, there are some new items within the marketplace that would be acceptable to use and comply with any welfare concerns. Include must be worn in their manufactured state as this then allows any spur with degradation shown, falls under an elimination.

**NF Proposal**

**8427.7** Spurs are optional as a standard compensating aid. Spurs ~~must~~ **can** be made of metal **or a flexible non-brittle material and used in their manufactured state**. The shank must be either curved or straight, pointing directly back from the centre of the spur when on the Athlete's boot. Spurs must not be offset, unless allowed as a non-standard compensating aid and noted on the FEI Classification Master List. The arm of the spur must be smooth and blunt. If rowels are used, they must be blunt, smooth and free to rotate. Metal spurs with round hard plastic knobs ('Impuls' spurs) or "Dummy" spurs with no shank are also allowed.

**FEI Feedback**

This request was refused in Dressage and Para Dressage, as the Technical Committees felt that a non-metal material was more likely to deteriorate and cause friction on the Horse's side.

In 2023 a full equipment revision will take place in all disciplines, and spurs will be included.

Each bit must be attached to a separate rein and reins may only be attached to the bit so that the reins can freely glide. Reins must not be made of rope or rope-like material. Any rein from any bit in the Horse's mouth must be in direct contact with the Athlete".</p> <p>The use of clip on reins would be for Athletes who have a diagnosis of controlled epilepsy, as there may be there need for the reins to be removed quickly and efficiently by a support person in the event of a seizure where the athlete cannot let go of the reins or needs to be assisted to dismount and put in the epilepsy recovery position. This practise would assist the combination and others to stay as safe as possible in this type of incident.</p> <p><b>NF Proposal</b></p> <p>Clip on reins may be used when there is an eligible impairment which requires the reins to be removed quickly and efficiently by a support person in the event of a seizure when the athlete cannot let go of the reins or needs to be assisted to dismount and put in the Epilepsy recovery position.</p> <p><b>FEI Feedback</b></p> <p>The PETC did not agree to this change in 2022, as a full equipment review will take place in 2023.
