	REPORT OF THE FEI VAULTING COMMITTEE 2023	
1.	The 2023 Vaulting season kicked off in early January and will conclude in November, which marking a significant development for our discipline with 29 CVI events organised throughout the entire year.	
	The Vaulting Technical Committee (VTC) would like to extend their appreciation to the Organisers, Athletes, Trainers, Horse owners, Grooms, Sponsors, and everyone who contributed to the success of these events.	
	Looking ahead, we encourage Organisers and National Federations to aim for even more events in 2024.	
	The VTC wants to express their gratitude to the Organiser of the very successful combined FEI Vaulting World and European Championships that took place in Flyinge (SWE).	
	Their hard work and commitment to excellence have not gone unnoticed, and the VTC greatly values their professionalism and contributions to the Sport of Vaulting.	
2.	ACTIVITIES OF THE FEI VAULTING TECHNICAL COMMITTEE (VTC)	
	From February to July, VTC invested a lot of effort in preparing rules 2024 and Guidelines 2024; both documents were published in the planned timeline. The main proposed changes in the 2024 rule and 2024 guideline, concerned the Squad and Pas de Deux. The implementation of the new qualification criteria for horses and squads to participate at the 2024 FEI Championships (subject to FEI GA approval) is a significant part of these changes.	
	All these changes were centered on the well-being of the horse and the sustainability of our sport.	
	The VTC met twice a month for online meetings, followed by extensive offline communication within the VTC and with the FEI.	
	This year, the VTC proactively adhered to a clear timeline for the publication of the Guidelines. The draft version was published on 14 September to be effective as of 1 January 2024. This timeline allows the community ample time to become familiar with the Guidelines and provide valuable feedback to the VTC well in advance of the effective date.

	On 3 February, the VTC organised an Online Forum, open to the entire Vaulting community. More than 150 participants from over 20 countries joined the forum. The topics discussed were dedicated to the outcomes of the survey on the future of the sport. This survey, along with fruitful discussions within the community, provided solid elements to the VTC for working on the proposed changes to the Rules and Guidelines for 2024. The forum also addressed the changes in Rules and Guidelines for 2023 and highlighted important topics that the VTC wished to share.
	At the beginning of November (from 3 to 5 November), the Vaulting community will gather in person in Austria for the Annual FEI Vaulting Seminar. The agenda primarily focused on explaining the rule and guideline changes for 2024. Additionally, the first-ever hybrid session will be organised, bringing together the FEI Vaulting department and the FEI Veterinary department for informative and open discussions with the vaulting community on the following topics:

	Other interesting sessions will be presented by the FEI Education Department and the FEI Vaulting Department.
	November 2023 is going to be dedicated to incorporating the community's feedback after the Seminar and making a final version of the 2024 Guidelines to be approved by FEI Board at the Board Teleconference that will take place in December 2023.
