WHEREAS, on 24 October 2008, Mr Rodrigo Pessoa (the "Appellant") filed an appeal with the Court of Arbitration for Sport ("CAS") against the Fédération Equestre Internationale ("FEI" or the "Respondent") with respect to a decision rendered on 3 October 2008 by the FEI Tribunal, whereby the Appellant was suspended for a period of 4.5 months and fined CHF 2,000.—;

WHEREAS the Appellant's statement of appeal, filed in French, also included an application to stay the execution of the challenged decision;

WHEREAS, on 28 October 2008, the CAS initiated an appeal arbitration procedure under the reference CAS 2008/A/1680 Rodrigo Pessoa v/Fédération Equestre Internationale;

WHEREAS, on 30 October 2008, the Respondent requested English to be the language of the procedure and filed its answer to the Appellant's request for stay;

WHEREAS, on 31 October 2008, the Appellant filed its observations on the language of the arbitration;

WHEREAS, on 6 November 2008, the CAS issued an order regarding the language of the arbitration, which shall be English;

WHEREAS, on 6 November 2008, the CAS issued an order on the request for a stay dismissing this request;

WHEREAS, on 18 November 2008, the Appellant informed the CAS that he has decided to withdraw his appeal;

WHEREAS, on 19 November 2008, the CAS Court Office took due note of the withdrawal of the appeal and informed the parties that a termination order will be issued by the Deputy President of the CAS Appeals Arbitration Division;

WHEREAS in view of the above, the withdrawal of the appeal by the Appellant shall be recorded and the arbitration procedure CAS 2008/A/1680 Rodrigo Pessoa v/Fédération Equestre Internationale shall be terminated and removed from the CAS roll;

WHEREAS no further costs shall be payable by the parties, except for the Court Office fee of CHF 500 (five hundred Swiss Francs), which has already been paid by the Appellant and is retained by the CAS pursuant to article R 65.2 of the Code of Sports-related Arbitration (Code).

- 2. Terminates the arbitration procedure CAS 2008/A/1680 Rodrigo Pessoa v/Fédération Equestre Internationale and deletes it from the CAS roll.
- States that the present order is rendered without costs, except for the Court Office fee of CHF 500 (five hundred Swiss francs), paid by Mr Rodrigo Pessoa, which is retained by the CAS.
