What are Athlete Services?

Athletes Services are all services provided by the FEI, benefiting directly or indirectly the FEI Athletes



Direct services

Services where Athletes can directly interact with the FEI by using them



Indirect services

Services that are benefiting the Athlete, meaning they contribute to the quality, improvement or regulation of the sport

Online calendar of competitions, event schedules, qualification systems, FEI Entry System, FEI Invitation System, FEI SportManager App



Evolution of FEI direct Services for Athletes over the years













FEI revenues from Athletes yearly registration fees





Evolution of FEI Operational Budget






Operational results — Operational revenues — Operational expenses * Budget
