Article 6.9.4 – Athletes Committee Election

Explanation for Proposed Change

To streamline the election of the Athletes Committee representative by their peers.

Proposed Wording

1. Criteria for Candidate Selection

The IJRC proposes that the Athlete representative must:

- Be a trustworthy figure chosen according to selective, objective criteria;
- Have the ability to represent a particular field;
- Be capable of understanding and representing an international perspective within an international federation;
- Have represented his or her country in team during Olympic Games or, alternatively, in the World or European Championships, or in 5 CSIO 5* events (that fulfil the technical FEI requirement 1.60m), in the eight years preceding the elections;
- Not have been found guilty of any doping offences;
- Be at least 25 years old.

2. Voting Rights

As this is an international environment, we suggest the following criteria:

- The athlete must have represented his or her country in the Olympic Games in the eight years preceding the elections, or, alternatively, in the World or European Championships, or in 5 CSIO 5* events. (These competitions have technical characteristics established and guaranteed by the FEI.)

Alternatively, they must be among the first 500 on the Longines FEI Ranking List.

FEI Feedback

The FEI, after having analysed the IOC guidelines for the creation of an IF Athletes Committee, having received the feedback from all relevant Technical Committees, and aiming to have an harmonised approach across all Disciplines proposed the wording below.

FEI Proposed Wording (if applicable)

"One Athlete shall be elected for each Discipline to serve as the Athlete representative on that Discipline's Technical Committee and to ultimately together form the Athletes Committee. These Athlete representatives shall be elected via an online vote by their peers. ~~which will be open for eight weeks and will finish at the end of the FEI World Equestrian Games™.~~

GER NF

The wording proposed by the FEI includes that those entitled to vote or to be elected "have not committed any violation of the FEI EADCMR or the FEI ADRHA within the previous 10 years".

- 1- We suggest to differentiate between the active right to vote and the passive right to be elected. This is also done in criminal procedures. No Athlete who is allowed to participate in the sport should be prevented from casting a vote.
- 2- Secondly, we consider a ban of ten years for an Athlete who has gone through a fast track procedure where "fault or negligence" is not even identified as too long.
- 3- Finally, will an Athlete be previously suspended from the duties as Athletes' Representative during a pending trial or will he/she only be removed after the FEI Tribunal decision?

IRL NF

- 1- IRL NF note that it should be the Athletes Committee that appoint a replacement in the event that an Athlete Representative is unable to complete a term.

- 2- IRL NF also consider excluding an athlete because of 1 Medication offence a bit harsh but have no proposed alternative wording.

INTERNATIONAL DRESSAGE RIDERS CLUB (IDRC)

The IDRC is the legitimate worldwide professional body for dressage riders. The riders and horses are the combination that make up the sport and therefore the core and heart of the sport.

Thus, the riders and their horses play a very decisive role, because without them, this sport would not exist.

This central importance should also be reflected in the relationship between the FEI and the legitimate professional organizations. Therefore, the IDRC consider it necessary to put the current basis of cooperation on a new footing.

From our point of view, it is incomprehensible that the representative in the respective committees is not delegated by the legitimized professional associations.

In order to be able to guarantee a trusting, fast and effective communication and coordination of the content of the topics, it is necessary that the riders representative in the DC is appointed by the IDRC.

The current situation leads to the conclusion that the IDRC formally has no influence on the position of the riders representative in the Dressage Committee.

The IDRC represents the interests of the riders, but cannot influence the voting behavior of the riders representative. Furthermore, due to this formal legal separation, the flow of information is currently severely restricted.

- 1- Comment taken into account and proposed wording modified accordingly;
- 2- Comment taken into account and proposed wording modified accordingly;
- 3- The Athlete Representative would be suspended of his/her functions when a violation is confirmed by the FEI Tribunal, or in case of a fast track when the Athlete accepts it.

IRL NF

- 1- As Athletes Representatives are elected by their peers by Discipline, it is proposed to keep the replacement formula;
- 2- Already taking into account as part of the GER NF comment.

IDRC

The FEI follows the IOC Guidelines for the creation of an Athletes Committee according to which the Athletes are to be elected by their peers. IDRC has the right to submit a candidate and to campaign for it so to get elected by the whole athletes community.
