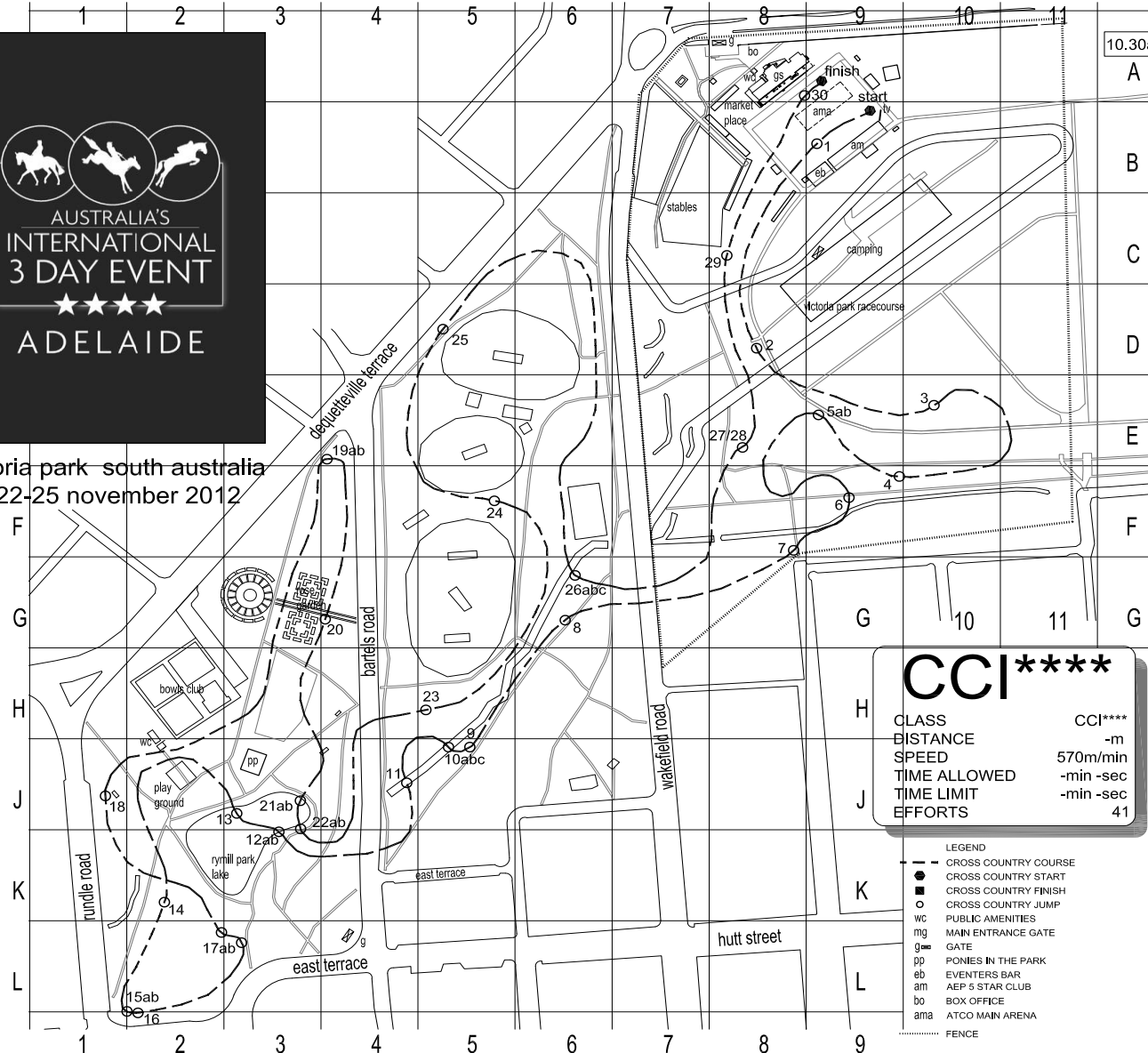

Risk Management Policy



- The AI3DE Risk Management Policy comprises of 5 sections:
 - *Overall RM Policy*
 - *OH&S Policy incorporating the Risk Identification Strategy and Standard Procedures*
 - *Equestrian Crisis Management Plan*
 - *Equestrian Risk Management Plan*
 - *Emergency Management Plan*

Risk Management Policy

- Contractors obligations and legislation:
 - *Occupational Health, Safety and Welfare Act 1986*
 - *Equal Opportunity Act 1984 (SA)*
 - *Environmental Protections Act 1993*
 - *SA Food Act 1993*



Public Liability



- Levels of Risk
 - *High Risk agents - \$20m*
 - *Medium Risk - \$10m*
 - *Low Risk - \$5m*
- Agent categories
 - *Venue contractors*
 - *Entertainers*
 - *Caterers*
 - *Service Providers*
 - *Commercial Exhibitors*

Hazard Management

- Hazard Management encompasses:
 - *Dangerous or Emergency Situations*
 - *Induction Training*
 - *Equipment Standards*
 - *Hazard Reporting*



Venue Management

- Traffic Control
 - *Authority to use vehicles at the event*
 - *Speed limits*
 - *Driving tips*
 - *Traffic restrictions*

Other:

- *Responsible persons*
- *Supplied products*
- *Catering and alcohol*
- *First aid*
- *Staff presentation and work practices*



Incidents

- Incident reporting
- Hazardous substances
- Fire safety
- Housekeeping



Cross Country Course



- Designed by an FEI Course Designer
- Built to the highest safety standards
- Site Manager to control all movement of structures
- Maximum speed of vehicles 10kph
