Steward & Chief Steward at all levels of International Competition

Requirements

- ✓ English proficiency grade of B2 or higher
- ✓ FEI Level 3 Steward for a minimum of 2 years
- ✓ 2 positive evaluations as a Chief Steward at different Eventing venues
- ✓ Be in good standing with the FEI
- + Officiating experience before application**
- ✓ 5x CCI4-5* at different venues or CH2-5* as a Chief Steward or Assistant Chief Steward

Maintenance

- ✓ CES Online Assessment every year
- ✓ CES Maintenance Course every 3 years
- ✓ 6 Intl. Events in any Olympic discipline, including 3x CCI within the last 3 years as a Level 4 Steward ¹
- ✓ 1 positive evaluation at a CCI4*-5* within the last 3 years as a Level 4 Steward ¹, completed by a Level 4 Ground Jury Member and a Level 4 Technical Delegate in their function for min. 2 years

Education

For Transfer-up

- ✓ Pass the Transfer-up Level 4 Stewards Education with examination(s):
 - Pass the online problem-solving case studies
 - Pass an online interview
 - The case studies and the interview must be passed by the Official to be provisionally transferred-up to Level 4 and invited to the second phase
 - Pass a three-day in-person course at FEI HQ
 - If passed, the transfer-up to Level 4 is confirmed

Level 4 Eventing Steward

- ✓ On passing the Level 4 examinations and fulfilling all requirements, participants are listed as Level 4 Stewards in the FEI Database.

Steward at CCI1-5* & CHs 1-5* / Chief Steward at CCI1-4* & CHs 1-3*

Requirements

- ✓ English proficiency grade of B1 or higher
- ✓ FEI Level 2 Steward for a minimum of 2 years
- ✓ 3 Intl. Events in Eventing as a Level 2 Steward within the last 3 years including :
 - 2x CCI2* or above as a Chief Steward
 - 1x CCI4* or 5* as an Assistant Chief Steward
 - 2 positive evaluations whilst officiating at different Eventing venues

Maintenance

- ✓ CES Online Assessment every year
- ✓ CES Maintenance Course every 3 years
- ✓ 4 Intl. Events in any Olympic discipline, including 1x CCI2* or above within the last 3 years as a Level 3 Steward ¹

Requirements

For National Stewards from NFs with Equivalency System

- ✓ English proficiency grade of A2 or higher
- ✓ Formally recommended by National Federation
- ✓ Completed online Eventing Foundation Course

For Level 1 Stewards

- ✓ English proficiency grade of A2 or higher
- ✓ 2x CCI as a Steward including 1x CCI as an Assistant Chief Steward within the last 3 years

Maintenance

- ✓ CES Online Assessment every year
- ✓ CES Maintenance Course every 3 years
- ✓ 2 intl. Events in any Olympic discipline, including 1x CCI within the last 3 years* as a Level 2 Steward ¹

*Condition non applicable to Equivalency Officials for the initial 3 years of officiating.

- ✓ Formally recommended by National Federation
- ✓ Completed online Eventing Foundation Course

Maintenance

- ✓ CES Online Assessment every year
- ✓ CES Maintenance Course every 3 years
- ✓ 2 intl. Events in any Olympic discipline within the last 3 years* as a Level 1 Steward ¹

*Condition non applicable for the initial 3 years of officiating at Level 1.

Note: Level 1 Stewards holding a Level 2, 3, 4 Judge and/or Technical Delegate function(s) are exempted from their Level 1 Steward maintenance requirement.
