


Eventing Technical Delegates Career Path

Assistant Technical Delegate at CCI1-5* & CHs 1-5* / Technical Delegate at CCI1-4* & J/YR, YH, Regional, Continental CHs

Requirements

- English proficiency grade of B1 or higher
- ✓ 3x CCI3* including 1 CCI3*-L within the last 3 years
- ✓ 1x CCI4* as an Assistant Technical Delegate within

Maintenance

- CES Online Assessment every year
- ✓ CES Maintenance Course (in-person) every 3 years 👬
- ✓ 3x CCI3-5* including 1 CC-L outside country of residence
- the last 4 years

The case studies and the interview must be passed by the Official to be provisionally transferred-up to Level 4 and invited to the second phase

Pass a three-day in-person course at FEI HQ If passed, the transfer-up to Level 4 is confirmed.

- 1x CCI3-5* outside of home country within the last 2 years as a Technical Delegate or Assistant Technical Delegate
- 2 positive evaluations Prior to the transfer-up in-person coursev

Education

For Transfer-up

- Attend an FEI Eventing education module on frangible \checkmark devices
- Pass an online interview Prior to the transfer-up in-person course
- Pass the Transfer-up Level 3 Technical Delegates in-person course with examination(s)
- within the last 3 years as a Level 3 Technical Delegate
- Attend an FEI Eventing education module on frangible devices every 3 years

Requirements

For National TDs from NFs with Equivalency System

- English proficiency grade of A2 or higher
- Formally recommended by National Federation
- Completed online Eventing Foundation Course
- Passed online Level 1 TD Equivalency Examination
- Shadow-officiated at a CCI2*-L or CCI3* with report

For Level 1 TDs

- English proficiency grade of A2 or higher
- 1x CCI2* within the last 2 years
- 1 positive evaluation Prior to the transfer-up in-person course
- 1x CCI2*-L or CCI3* as an Assistant Technical Delegate

Education

For Transfer-up

Pass the Transfer-up Level 2 Technical Delegates in-person course with examination(s)

Maintenance

- ✓ CES Online Assessment every year 📃
- CES Maintenance Course every 3 years
- ✓ 3x CCI within the last 3 years* as a Level 2 Technical Delegate ¹

*Condition non applicable to Equivalency Officials for the initial 3 years of officiating.
