Requirements

- ✓ English proficiency grade of B2 or higher
- ✓ Be in good standing with the FEI
- ✓ 2 positive evaluations as a Technical Delegate at 2 different Shows
- ✓ Be fit to officiate
- Officiating experience before application**
- ✓ 2x CCI4*-S in the last 3 years
- ✓ 2x CCI4*-L in the last 5 years
- 1x CCI5* as Assistant TD or 1x World CH, Senior CH, Continental Games as Assistant TD to a Level 4 TD
- ✓ 2x CCI4*-L or higher outside of home country, in the last 3 years including 1 as a TD

Maintenance

- ✓ CES Online Assessment every year
- ✓ CES Maintenance Course (in-person) every 3 years
- ✓ 3x CCI within the last 3 years as a Level 4 TD, including 1 Long Format
- ✓ 1 positive evaluation at CCI4*-L or CCI5* within the last 3 years as a Level 4 Judge, evaluated by a Level 4 PGJ & a Level 4 CD of the same class¹
- ✓ Attend an FEI Eventing education module on frangible devices every 3 years

Requirements

- ✓ English proficiency grade of B1 or higher
- ✓ 3x CCI3* including 1 Long Format in the last 3 years
- ✓ 1x CCI4-5* in the last 4 years as an Assistant TD to a Level 3 TD or above
- ✓ 1x CCI3-5* outside of home country in the last 2 years as a TD or Assistant TD
- ✓ Be fit to officiate

Maintenance

- ✓ CES Online Assessment every year
- ✓ CES Maintenance Course (in-person) every 3 years
- ✓ 3x CCI3-5* within the last 3 years as a Level 3 TD, including 1 Long Format¹
- ✓ Attend an FEI Eventing education module on frangible devices every 3 years

- ✓ Completed online Eventing Foundation course
- ✓ Passed online Level 1 TD Equivalency Examination
- ✓ 1x CCI2*-L or CCI3* as an Assistant TD
- ✓ Be fit to officiate

For Level 1 TDs

- ✓ English proficiency grade of A2 or higher
- ✓ FEI Level 1 TD for a minimum of 2 years
- ✓ 1x CCI2* as a Level 1 TD with positive evaluation
- ✓ 1x CCI2*-L or CCI3* as an Assistant TD only
- ✓ Be fit to officiate

Maintenance

- ✓ CES Online Assessment every year
- ✓ CES Maintenance Course (in-person) every 3 years
- 3x CCI within the last 3 years* as a Level 2 Technical Delegate¹
