

1. Introduction

Further to the update of the FEI IT system, it is possible to send the FEI the results in an **Excel file** allowing us to import directly in **XML format**. This procedure will hopefully simplify and speed up procedures for the OC, NF and FEI and will furthermore allow the results to be processed more efficiently to the benefit of all involved.

Please find below the description, information and explanations of the result files required in order to correctly and swiftly upload them into the FEI database. An example of a results file is attached to the end of this document.

- Please include Cross Country or Jumping Obstacle penalties for a combination having Retired or been Eliminated during that phase. If no Obstacle penalties were awarded, please indicate "0"
- o If a combination is Eliminated for refusals during the Cross Country or Jumping phase, please do not include the eliminatory penalty in the total Obstacle penalty scores. If for example a combination is eliminated for 3 refusals at the same obstacle, only the first two refusals will be taken into account for the scoring, i.e. 60 penalty points plus any additional penalty points awarded on course prior to Elimination.
- o Please do not exchange columns in the excel score sheet for a short format competition.

We strongly encourage you to carefully check that the results are accurate (correct code of elimination, correct Horses and Athletes IDs, all athletes included) as results cannot be modified once validated. The points below should be check carefully:

- o Missing combinations: please ensure that all combinations listed in the Fence Analysis are listed in the results and vice-versa.
- o Accuracy between Horse/Athlete IDs and names: please ensure that all IDs correspond to the correct Horse/Athlete.
- Accuracy of codes: please ensure that all codes are accurate and consistent between results, fence analysis, and fall report forms. Examples of possible inconsistencies to look out for:
 - > Eliminated for refusals is listed in the results but a fall report was filled out.
 - > Fall of Rider is listed in the results but the fall report states Fall of Horse.

The Eventing Department has been asking for the **fence analysis** to be sent to the FEI for each competition, for data reporting and Risk Management purposes. Please ensure to provide the fence analysis **together with the results of the Event** to allow the FEI to cross-check the information provided.

Please make sure that the following elements are accurately reported in the Fence Analysis:

- o Names of Athletes and horses to be used rather than start (bib) numbers
- o Please list all athletes having had faults on the Cross Country course and indicate on which fence the combination had a fault
- o All elements of a combination (i.e. 5A, 5B, 5C, etc.) must be listed



2. Detail of <Indiv>

The **Individual** tab of the excel file contains a set of elements in regard to the combination (Athlete/Horse) such as IDs and Names as well as their results.

The number of fields to be entered depends on the competition type.

The following information is mandatory for all CCI competitions:

Position: Rank of the combination: 1,2,3,... Classification to be made according to Art 502 of the Eventing Rules. No rank is to be mentioned for riders that are eliminated, retired, withdrawn or disqualified.

ns1:PosStatus

Status. If the rider is eliminated, retired or withdrawn please indicate one of the 4 abbreviations:

EL: eliminatedRET: retiredWD: withdrawnDSQ: disqualified

No other code accepted.

PosStatusComplement: Status complement. The status complement describes when EL, WD or RET took place therefore please use the following codes:

EL (Eliminated):

- Dressage
- XC-Warm-up
- XC (Cross Country test)
- o Additionally please include for XC:

- XC-EC (Error of course including missed jump)

WD (when the combination Withdraws before the following):

- Dressage
- XC (for cross country test)

RET (when the combination Retires <u>during</u> the following):

- Dressage
- XC (for cross country test)
- SJ (for jumping test)
- 1st HI
- 2nd HI

If PosStatus=DSQ then PosStatusComplement must contain one of the following values :

No other codes are accepted.

CompetitorFEIID: The FEI ID of the rider. The rider MUST be listed in the FEI database and MUST be registered for the current year. The FEI ID must be entered without any space.

CompetitorFirstname: The First Name of the Rider. The system will compare the first name with the one in the system.

CompetitorFamilyname: The Family Name of the Rider. The system will compare the family name with the one in the system.

CompetingFor: IOC Code - Sport Nationality of the rider. Use the 3 letters of the Olympic Committee (OC) abbreviations as described here: https://olympics.com/ioc/national-olympic-committees

HorseFEIID: The FEI ID of the horse. The horse MUST be listed in the FEI database and MUST be registered for the current year. The FEI ID must be entered without any space.

HorseCompleteName: The horse complete name. The system will compare the name with the one in the system.

DressagePenalty: Dressage score in penalty points must be mentioned according to Art 526 of the Eventing rules. Only **positive values with one decimal point** are accepted, no other code accepted. When there are decimals, please use a point (.) and not a coma (,).

CCObstaclePenaltyD: Cross Country obstacle penalties are to be mentioned according to Art.532 of the Eventing rules. Only positive values are accepted, no other code accepted.

CCTimePenaltyD: Cross country time penalties are to be mentioned according to Art. 532 and 532.2 of the Eventing rules. Only positive values with decimal points are accepted, no other code accepted.

JumpingObstaclePenalty: Jumping obstacle penalties are to be mentioned according to Art 538 of the Eventing rules. Only positive values are accepted, no other code accepted.

JumpingTimePenalty: Jumping time penalties are to be mentioned according to Art 538.2 of the Eventing rules. Only positive values are accepted, no other code accepted.

TotalPenalty: Total Penalties; addition of dressage penalties, time and obstacle penalties from cross country and jumping. Only positive values with decimal points are accepted, no other code accepted.

TeamNF: The IOC Code of the Team. Please leave this field empty for riders that compete only for individual ranking. A IOC Code must be entered if the combination is competing in a team (must match with the team NF field in the results page/tab for teams). Use the 3 letters of the Olympic Committee (OC) abbreviations as described here: https://olympics.com/ioc/national-olympic-committees



Prize: The prize won. Number without currency, symbols or spaces

PrizeCurrency: The prize currency only. Please use the three letter ISO currency code. No other code or symbol accepted.

QualifiedForJumping2: For FEI use only. Please leave this element empty.

IsWNominated: For FEI use only. Please leave this element empty.

SJBeforeXC: The value **TRUE** must be included for each combination when the Show Jumping test took place before the Cross Country test and the value **FALSE** must be included in all other cases.

3. Detail of <Team>

Position: Rank of the team. No rank for the teams who are eliminated, retired or withdrawn.

PosStatus: Status. If the team is eliminated, retired or withdrawn. Write down one of the 3 abbreviations (No other code accepted):

EL: eliminatedRET: retiredWD: withdrawn

NF: The Nationality of the team. Use the 3 letters of the Olympic Committee abbreviations as described in Annex I.

TeamName: The name of the team. The nationality abbreviations or Team names if there are several teams from the same country.

Prize: The prize won. Number without currency.

PrizeCurrency: The prize currency. Please use the three letter ISO currency code.

TotalPoints: The total penalties obtained by addition of the three highest placed athletes in the team as per Art. 502.3 of the Eventing rules.

A rider who fails to compete as team member will be awarded 1000 penalty points.

Only positive values with decimal points are accepted, no other codes or symbols are accepted.
