











Clean Sport at the Paris 2024 Olympic Games - 11 July 2024

Welcome to our third and final Clean Sport emailer in view of the upcoming Paris 2024 Olympic Games. RECOMMENDATIONS FOR EQUINE AND HUMANS ATHLETES GOING TO PARIS

Humans

For all athletes and athlete support personnel going to the Paris 2024 Olympic Games, now is a good time to:

- Take the dedicated e-learning "ADEL for Paris 2024 Olympics" available on WADA's ADEL online educational platform to understand what anti-doping will be like in Paris.
- 2. Review the "Pre-Arrival to-do list" in the **FEI Doping & Medication Control Guide for Paris 2024** and make sure all relevant action is taken.
- 3. Watch on replay the **International Testing Agency (ITA)'s 30 May 2024** webinar: "Olympic Games Paris 2024 Anti-Doping Program" on the ITA's YouTube channel.

Remember:

Athletes are strictly liable for any prohibited substance found in their bodily sample collected during testing, regardless as to how it got there or whether they had any intention to cheat ("strict liability").

Stay up to speed

Make sure you are up to date with all the latest Anti-Doping and Controlled Medication information so that you stay within the rules!

Elective Testing

It is possible to submit blood and urine samples from your horse to ensure he is free from any Prohibited Substances. The Pre-Arrival Testing service is open until five days prior to the horses arriving in Paris. Click **here** for more information.
