## Doping & Medication Guide for the Paris 2024 Paralympic Games now available online

The FEI has compiled a **Doping & Medication Guide for the Paris 2024 Paralympic Games**, to ensure that both Athletes and Horses competing at the Games will be compliant with the anti-doping rules. Alongside this essential tool, we would also like to remind you that detailed information on both human and equine anti-doping is available to you on the **FEI Clean Sport** website.

### Anti-doping preparations – Get started now

In order to prepare for clean Games, the first thing you need to do is make sure you are well informed. The **Doping & Medication Guide for the Paris 2024 Paralympic Games** redirects you to resources made available to you, such as, but not limited to, valuable reading material, e-learning platforms and webinars.

Now is also the time to review all Athlete and Horse medical/veterinary treatments in line with the applicable rules and procedures. You can find out more on this topic under the sections "How should you prepare?" and "Your pre-arrival to-do list" of the **Doping & Medication Guide for the Paris 2024 Paralympic Games**.

## Reminder - Clean Sport for humans

For an athlete, testing positive at Paralympic Games means:

- Disqualification of results (including team results in the case of a team competition).
- Loss of any medals, points and prizes (including those won by the team in the case of a team competition).
- Possible financial consequences (fines; contribution towards legal costs)
- Possible ineligibility period (suspension) of the athlete.

### **Therapeutic Use Exemption (TUE)**

Avoid unintentional doping violations by making sure that you hold a Therapeutic Use Exemption (TUE) for any prescribed treatment containing prohibited substances. Consult the **Doping & Medication Guide for the Paris 2024 Paralympic Games** for details.

Some doping violations can be committed by people who are not athletes. If you work as part of an athlete's support personnel, you should read the Paris 2024 Doping & Medication Control Guide!

## **Reminder - Clean Sport for horses**

A horse testing positive at Paralympic Games means:

- Disqualification from the competition.
- Loss of any medals, points and prizes
- Possible ineligibility period (suspension) of the athlete.
- Possible provisional suspension of the horse.

Measures you can take to stay within the rules:

- We encourage all participating NFs to use the Pre-Arrival Testing service to check that horses are free from prohibited substances. Click [here](#) for further information.
- It's not just a positive test that can land you in trouble. Other anti-doping rule violations include refusing to submit the horse for sampling when selected, possession of a Banned Substance and tampering with any part of the sampling equipment and process.
- Carefully read the Doping & Medication Guide for the Paris 2024 Paralympic Games to ensure that you are in compliance with the regulations.
