FEI Event Medical coverage

- Full revision of the "Guidelines for the medical coverage of events in compliance with article 109.10, GRs"
 - Aim: outline requirements in more detail to help Organising Committees plan their event's medical response.
 - The revised document is published on the FEI website and will come into effect on 1 January 2024.
- Reminder: Eventing Annex D mandatory since 1 January 2023.

NF Medical Advisor project

- National Federation Medical Advisor project to be developed in collaboration with the FEI Solidarity department to support and enhance athlete safety and health
- Assist NFs on related matters such as athlete injury reporting, concussion management and education, human anti-doping compliance and education and local FEI event medical coverage needs
- Focus on smaller NFs with limited support staff
- Current phase: development of program framework and educational curriculum for NF Medical Advisors.

Personal Safety Equipment

Equestrian Helmets

- The list of accepted testing standards groups for helmets has been updated, effective 1 January 2024
- The helmet working group evaluated the performance needs of protective headwear and assessed the existing standards against those needs to better determine if existing testing standards could be improved to provide better protection of riders from serious head injuries
- Recommended additional testing measures and reduced energy transmission limits for improved athlete safety

Personal Safety Equipment

Equestrian Air Vests


- Despite increased use of air vests in several equestrian disciplines, there is very limited data on their effectiveness in reducing serious rider injuries
- Create a collaborative working group on air vests safety and effectiveness
- Complete literature review of all available data including other sports
- Develop research projects including computer simulations/modelling and physical testing protocols under realistic rider fall loading conditions
- Translate these findings into new testing standards recommendations for improved rider safety
