# **EQUESTRIAN CENTER IN TEMECULA PROPOSED AS NEW VENUE FOR LA28 EQUESTRIAN EVENTS**

The Organising Committee for the Olympic and Paralympic Games in Los Angeles 2028 (LA28) has announced plans to move equestrian and para equestrian competitions to an existing purpose-built facility in Temecula, Southern California, emphasising sustainability, legacy, and fiscal responsibility in their decision.

The relocation of equestrian and para equestrian events, which were previously assigned to the Sepulveda Dam Recreation Area, will achieve significant cost savings by eliminating the need to construct an expensive, entirely temporary venue.

# FEI SAFEGUARDING INITIATIVE AT THE FEI VAULTING CHAMPIONSHIPS, BERN (SUI)

The FEI will be running a Safeguarding initiative on **Tuesday 16 July 2024**, at the FEI World Vaulting Championships in Bern to raise awareness among the equestrian community on the importance of safeguarding. The aim of this initiative is to raise awareness and provide guidance as to what each one of us can do to ensure a safe environment for everyone involved in equestrian sport.

The initiative will be comprised of two activities:

- 1. An interactive presentation/workshop for Chefs d'Equipe, Coaches, Trainers, Lungers, Support Personnel and all FEI Officials from **10h30-11h30 in the Media Room.**
- A Safeguarding booth for athletes, grooms and support personnel from 12h 15h by the canteen.

We strongly encourage everyone attending the FEI World Vaulting Championships to participate in this important initiative.

# ASOIF GOVERNANCE REVIEW - FEI RECEIVES TOP TIER RANKING ONCE AGAIN

The FEI secured a top-tier placing in the fifth review of International Federation Governance conducted by the Association of Summer Olympic International Federations (ASOIF). This is the third time the FEI has earned a leading position after welcoming top classification in the previous two editions.

The evaluation was conducted by the ASOIF Governance Task Force. As is customary in this process, it took the form of a self-assessment questionnaire with independent moderation of the responses. The questionnaire consisted of the 60 measurable indicators equally divided among five sections: Transparency, Integrity, Democracy, Development, and Control Mechanisms. Some 32 International Federations took part in the review.

The FEI is one of the seven IFs – the others being the BFW (Badminton), FIFA (Football), ITF (Tennis), UCI (Cycling), World Athletics, and World Rugby – which, according to the review, "stood out from the rest" having secured at least 210 out of a maximum of 240 points.

### **Update on Qualification Criteria**

We would like to inform you that the Qualification Criteria document for Championships in 2025 has been updated in order to reflect the addition of the Para Driving World Championship and the advancement in the publication of the new dressage tests.

The document is available on the **FEI Driving hub** on inside.FEI.org and all modifications are visible in red.

### **CES ONLINE ASSESSMENT - REMINDER**

We would like to remind everyone that all FEI Officials must have "passed" their annual CES Online Assessment to officiate at FEI Events.

#### As of 1 August 2024, the following FEI Event Schedule Policy will apply:

Officials must have "passed" their CES Online Assessment of the current year to be added to schedules of events taking place after the 31 March.

For information, the officiating/maintenance year runs from the 15 December of each year and until the 15 December of the following year.

- Every year, from 16 December to 31 March (transition period), Officials with an open function can still officiate without having passed the annual CES Online Assessment of the current year.
- Every year, from 31 March to 14 December (regulated period), Officials must have passed the CES Online Assessment of the current year to officiate, and to keep their function open.
