Education System for FEI Jumping Officials

Introduction

The FEI Education System is designed to ensure that all FEI Jumping Officials can fulfil the requirements of their job descriptions, are up-to-date with the current FEI Rules and Regulations, and master the officiating know-how in their discipline. Its goal is to guarantee that FEI Officials apply a consistent approach to the Jumping matters, deliver high-quality officiating and provide a true level-playing field to competitors at all international equestrian events, while keeping the Welfare of the Horse as paramount in their practice at all times.

The FEI Education System offers function-specific career pathways, structured with a gradual four-level (4) system. National Jumping Officials, upon successfully completing their initial transfer-up process will be listed as Level 1 FEI Jumping Officials (Judge, Steward or Course Designer), and in case of an equivalency agreement with their NF, as Level 2 FEI Officials. They may later evolve up the pathway to higher levels.

Competencies

To officiate at a given function and level, FEI Jumping Officials must hold the relevant FEI Official Certificate, which ensures they currently have the following required competencies:

- ✓ Knowledge of FEI Rules and Regulations
- ✓ Knowledge of the sport, the discipline, the horse and its wellbeing
- ✓ Experience in the discipline and the function
- ✓ Interpersonal and communication skills
- ✓ Fitness level required to correctly perform all duties relevant to the role
- ✓ English language proficiency

English language proficiency is mandatory as all FEI Officials are working in an English-speaking environment, will be expected to write reports in English, and must understand FEI Rules and Regulations and course material.

The level of English language proficiency required is in-line with the level of officiating, and based on the Common European Framework of Reference for Languages (CEFR) as a reference:

Level 1	A2	The user can understand phrases related to areas of relevance, can read very short and simple texts, communicate in simple ways and write short messages.
---------	----	---

Level 2	B1	The user can understand the main points of clear speech, can understand a text that consists mainly of high frequency job-related language, can deal with most situations likely to arise, can describe show in a simple way and write simple texts on topics which are familiar.
Level 3	B2	The user can understand complex lines of arguments provided the topic is familiar, can read reports in which the writers adopt particular attitudes or viewpoints, can present clear, detailed descriptions related to the field of interest and write detailed texts related to the subject of interest.
Level 4	C1	The user can understand extended speeches, can understand long and complex texts, express him/herself fluently and spontaneously, present complex subjects and write well-structured texts.

Competency-based Evaluation System

In order to assess, educate, certify and monitor competencies of FEI Jumping Officials throughout their career, the FEI has implemented the Competency-based Evaluation System (CES). The CES ensures that both during the transfer-up and the maintenance phases of a given function/level, Officials have the required competencies to officiate at international level.

The transfer-up consists of:

- Requirements - to ensure candidates have the minimum level of knowledge and experience before starting their education
- Education with examination(s) - in line with the job description to prepare Officials in taking and assuming their roles and duties
- Certification - to validate Officials competencies for a given function and level

The maintenance consists of:

- The annual CES Online Assessment
- The triennial CES Maintenance Course
- The annual CES Officiating Review¹

Maintenance is mandatory for all FEI Jumping Officials and their status is reviewed annually by the FEI on 15 December.

All Officials are required to take their assessments and examinations personally.

The FEI reserves the right to verify (by whatever method the FEI may choose) that an assessment/examination has been personally completed by an individual Official. If the FEI concludes that the assessment/examination has not been personally completed by the relevant Official, the FEI can take such action as it deems necessary including, but not limited to the invalidation of the assessment/examination and/or the opening of disciplinary proceedings.

Minimum Requirements for Eligibility to become an FEI Official

For their application to be considered, FEI Jumping Officials must:

- ✓ Have an appropriate level of English, both written and spoken
- ✓ Be minimum 18 years old
- ✓ Be in good standing with their National Federation
- ✓ Be familiar with and accept the FEI General Regulations, FEI Jumping Rules, FEI Veterinary Regulations and Annexes, and other relevant FEI Jumping manuals and guidelines
- ✓ Accept all applicable Codes and Codes of Conduct
- ✓ Be formally recommended by their National Federation

National Federations are responsible for informing the FEI Jumping Department of any Official who is not in good standing with the National Federation.

Event Participation

Lists of FEI Jumping Officials are available on the FEI website for the use of Organising Committees and other interested Stakeholders, and are updated on a daily basis. Only FEI Jumping Officials who are current with their maintenance status and report submission obligations will be listed, and may officiate at, or be appointed to FEI Events.

FEI Jumping Officials must abide by the applicable Codes of Conduct and commit to act according to the principles, Rules and Regulations of the FEI.

The duties of FEI Jumping Officials are outlined in the FEI Jumping Job Descriptions. However, these documents do not substitute FEI Rules and Regulations.

- ✓ Be formally recommended by their National Federation
- ✓ Achieve an English proficiency grade of A2 or higher
- ✓ Complete the online Jumping Foundation Course

National Judges from NFs with Equivalency wishing to be listed as a Level 1 Judge must:

- ✓ Be formally recommended by their National Federation
- ✓ Achieve an English proficiency grade of A2 or higher
- ✓ Complete the online Jumping Foundation Course

Education

For National Judges:

- ✓ Pass a Transfer-up Level 1 Course for Judges with examination

If an examination is not passed, the Official is given the opportunity of a re-attempt after one (1) year.

For National Judges from NFs with Equivalency:

- ✓ Pass an online Transfer-up Level 1 Course for Judges with examination and an online interview or pass an in-person Transfer-up Level 1 Course for Judges with examination

If an examination is not passed, the Official is given the opportunity of a re-attempt after one (1) year.

Status

- ✓ On passing the Level 1 examination(s) and fulfilling all requirements, participants are listed as Level 1 Judges in the FEI Database

Roles at FEI Events

According to FEI Jumping Rules Art. 259, Level 1 Judges may take on the following role at FEI Events:

- ✓ Ground Jury Member

Maintenance

To maintain status, Level 1 Judges must:

- ✓ Pass a CES Online Assessment every year
- ✓ Pass a CES Maintenance Course every three (3) years
- ✓ Have officiated as a Level 1 Judge at least at three (3) International Events or FEI Challenges within three (3) years*¹

*condition not applicable for the initial three (3) years of officiating at Level 1.

Level 2 Jumping Judges

Requirements

Level 1 Judges wishing to be listed as a Level 2 Judge must:

- ✓ Achieve an English proficiency grade of B1 or higher
- ✓ Have been listed as an FEI Level 1 Judge for a minimum of one (1) year
- ✓ Have officiated as a Level 1 Judge at least at six (6) International Events

National Judges from NFs with Equivalency wishing to be listed as a Level 2 Judge must:

- ✓ Be formally recommended by their National Federation
- ✓ Achieve an English proficiency grade of B1 or higher
- ✓ Complete the online Jumping Foundation Course
- ✓ Pass the online Level 1 Judges Equivalency Examination

Education

For Level 1 Judges:

- ✓ Pass a Transfer-up Level 2 Course for Judges with examination

If an examination is not passed, the Official is given the opportunity of a re-attempt after one (1) year.

For National Judges from NFs with Equivalency:

- ✓ Pass a Transfer-up Level 2 Course for Judges with examination

If an examination is not passed, the Official is given the opportunity of a re-attempt after one (1) year.

Status

- ✓ On passing the Level 2 examination(s) and fulfilling all requirements, participants are listed as Level 2 Judges in the FEI Database

Level 3 Jumping Judges

Level 2 Judges wishing to be listed as a Level 3 Judge must:

- ✓ Achieve an English proficiency grade of B2 or higher
- ✓ Have been listed as an FEI Level 2 Judge for a minimum of two (2) years
- ✓ Have officiated as a Member of Ground Jury at a minimum of six (6) International Events in the last three (3) years

Education

- ✓ Pass a Transfer-up Level 3 Course for Judges with examination
If an examination is not passed, the Official is given the opportunity of a re-attempt after one (1) year.

Status

- ✓ On passing the Level 3 examination(s) and fulfilling all requirements, participants are listed as Level 3 Judges in the FEI Database

Roles at FEI Events

According to FEI Jumping Rules Art. 259, Level 3 Judges may take on the following roles at FEI Events:

- ✓ Ground Jury Member
- ✓ President of the Ground Jury
- ✓ Foreign Judge
- ✓ Limb Sensitivity Judge

Maintenance

To maintain status, Level 3 Judges must:

- ✓ Pass a CES Online Assessment every year
- ✓ Pass a CES Maintenance Course every three (3) years
- ✓ Have officiated as a Level 3 Judge at least at three (3) International Events within three (3) years¹

Level 4 Jumping Judges

Requirements

Level 3 Judges wishing to be listed as a Level 4 Judge must:

- ✓ Achieve an English proficiency grade of C1 or higher
- ✓ Have been listed as an FEI Level 3 Judge for a minimum of four (4) years
- ✓ Be in good standing with the FEI

The following officiating experience has to be achieved within ten (10) years of the application:

- ✓ Have officiated as President of the Ground Jury at a minimum of five (5) CSI4*/5* or CSIO3*/4*
- ✓ Have been appointed and officiated as a Foreign Judge at a minimum of three (3) CSIO5*
- ✓ Have been appointed and officiated as a Member of the Ground Jury (Limb Sensitivity Judge excluded) at one (1) Senior Championship, Games, FEI Jumping World Cup™ Final or Longines League of Nations™ Final

Education

- ✓ Pass the Transfer-up Level 4 Education for Judges with examinations:

First phase:

- Pass online problem-solving case studies
If passed, invited to an online interview
- Pass an online interview
If passed, the Official is provisionally transferred up to Level 4 and invited to the second phase

Second phase:

- Pass a three-day in-person course at FEI HQ
If passed, the transfer-up to Level 4 is confirmed

If one of the two phases is not passed, the Official is given the opportunity of a re-attempt after one (1) year.

Status

- ✓ On passing the Level 4 examination(s) and fulfilling all requirements, participants are listed as Level 4 Judges in the FEI Database

Roles at FEI Events

According to FEI Jumping Rules Art. 259, Level 4 Judges may take on the following roles at FEI Events:

- ✓ Ground Jury Member
- ✓ President of the Ground Jury
- ✓ Foreign Judge
- ✓ Limb Sensitivity Judge

Maintenance

To maintain status, Level 4 Judges must:

- ✓ Pass a CES Online Assessment every year
- ✓ Pass a CES Maintenance Course every three (3) years
- ✓ Have officiated as a Level 4 Judge at least at six (6) International Events within the previous three (3) years of which a minimum of three (3) CSI4*/5* or CSIO3* or above¹

¹ The CES Officiating Review will not be applied, by decision of the FEI Board on 5 June 2024.

Level 1 Jumping Stewards

Requirements

Applicants wishing to be listed as a Level 1 Steward must:

- ✓ Be formally recommended by their National Federation
- ✓ Achieve an English proficiency grade of A2 or higher
- ✓ Complete the online Jumping Foundation Course

National Stewards from NFs with Equivalency wishing to be listed as a Level 1 Steward must:

- ✓ Be formally recommended by their National Federation
- ✓ Achieve an English proficiency grade of A2 or higher
- ✓ Complete the online Jumping Foundation Course

Education

For National Stewards:

- ✓ Pass a Transfer-up Level 1 Course for Stewards with examination

If an examination is not passed, the Official is given the opportunity of a re-attempt after one (1) year.

For National Stewards from NFs with Equivalency:

- ✓ Pass an online Transfer-up Level 1 Course for Stewards with examination and an online interview or pass an in-person Transfer-up Level 1 Course for Stewards with examination

If an examination is not passed, the Official is given the opportunity of a re-attempt after one (1) year.

Status

- ✓ On passing the Level 1 examination(s) and fulfilling all requirements, participants are listed as Level 1 Stewards in the FEI Database

Roles at FEI Events

According to FEI Jumping Rules Art. 259, Level 1 Stewards may take on the following role at FEI Events:

- ✓ Member of the Stewarding Team at CSI1*/CSIO1* up to CSI3*/CSIO3*
(Applicable since 01.01.2022)

Maintenance

To maintain status, Level 1 Stewards must:

- ✓ Pass a CES Online Assessment every year
- ✓ Pass a CES Maintenance Course every three (3) years
- ✓ Have officiated as a Level 1 Steward at least at three (3) International Events within three (3) years*¹

*condition not applicable for the initial three (3) years of officiating at Level 1.

- ✓ Achieve an English proficiency grade of B1 or higher
- ✓ Have been listed as an FEI Level 1 Steward for a minimum of one (1) year
- ✓ Have officiated as a Level 1 Steward at least at six (6) International Events

National Stewards from NFs with Equivalency wishing to be listed as a Level 2 Steward must:

- ✓ Be formally recommended by their National Federation
- ✓ Achieve an English proficiency grade of B1 or higher
- ✓ Complete the online Jumping Foundation Course
- ✓ Pass the online Level 1 Stewards Equivalency Examination

Education

For Level 1 Stewards:

- ✓ Pass a Transfer-up Level 2 Course for Stewards with examination
If an examination is not passed, the Official is given the opportunity of a re-attempt after one (1) year.

For National Stewards from NFs with Equivalency:

If an examination is not passed, the Official is given the opportunity of a re-attempt after one (1) year.

- ✓ On passing the Level 3 examination(s) and fulfilling all requirements, participants are listed as Level 3 Stewards in the FEI Database

Roles at FEI Events

Level 4 Jumping Stewards

- ✓ Achieve an English proficiency grade of C1 or higher
- ✓ Have been listed as an FEI Level 3 Steward for a minimum of four (4) years
- ✓ Be in good standing with the FEI

The following officiating experience has to be achieved within ten (10) years of the application:

- ✓ Have officiated as a Chief Steward at a minimum of five (5) CSI4*/5* or CSIO3*/4*
- ✓ Have been appointed and officiated as a Foreign Steward at a minimum of three (3) CSIO5*
- ✓ Have been appointed and officiated as a Member of the Stewarding Team at one (1) Senior Championship, Games, FEI Jumping World Cup™ Final or Longines League of Nations™ Final

Education

- ✓ Pass the Transfer-up Level 4 Education for Stewards with examinations:

First phase:

- Pass online problem-solving case studies
If passed, invited to an online interview
- Pass an online interview
If passed, the Official is provisionally transferred up to Level 4 and invited to the second phase

Second phase:

- Pass a three-day in-person course at FEI HQ
If passed, the transfer-up to Level 4 is confirmed

If one of the two phases is not passed, the Official is given the opportunity of a re-attempt after one (1) year.

- ✓ Pass a CES Online Assessment every year
- ✓ Pass a CES Maintenance Course every three (3) years
- ✓ Have officiated as a Steward at least at six (6) International Events within the previous three (3) years of which a minimum of three (3) CSI4*/5* or CSIO3* or above¹

¹The CES Officiating Review will not be applied, by decision of the FEI Board on 5 June 2024.

Level 1 Jumping Course Designers

Requirements

National Course Designers wishing to be listed as a Level 1 Course Designer must:

- ✓ Be formally recommended by their National Federation
- ✓ Achieve an English proficiency grade of A2 or higher
- ✓ Complete the online Jumping Foundation Course
- ✓ Have officiated as an Assistant Course Designer at three (3) International Events with a Mentor Course Designer Level 2 or above, with positive recommendations

National Course Designers from NFs with Equivalency wishing to be listed as a Level 1 Course Designer must:

- ✓ Be formally recommended by their National Federation
- ✓ Achieve an English proficiency grade of A2 or higher
- ✓ Complete the online Jumping Foundation Course

Education

For National Course Designers:

- ✓ Pass an in-person Transfer-up Level 1 Course for Course Designers with examination
If an examination is not passed, the Official is given the opportunity of a re-attempt after one (1) year.

For National Course Designers from NFs with Equivalency:

- ✓ Pass an online Transfer-up Level 1 Course for Course Designers with examination and an online interview or pass an in-person Transfer-up Level 1 Course for Course Designers with examination

If an examination is not passed, the Official is given the opportunity of a re-attempt after one (1) year.

Status

- ✓ On passing the Level 1 examination(s) and fulfilling all requirements, participants are listed as Level 1 Course Designers in the FEI Database

Roles at FEI Events

According to FEI Jumping Rules Art. 259, Level 1 Course Designers may take on the following roles at FEI Events:

- ✓ Assistant Course Designer
- ✓ Course Designer (build up to 140cm)

Maintenance

To maintain status, Level 1 Course Designers must:

- ✓ Pass a CES Online Assessment every year
- ✓ Pass a CES Maintenance Course every three (3) years
- ✓ Have officiated as a Level 1 Course Designer or Assistant Course Designer at least at three (3) International Events within three (3) years*¹

*condition not applicable for the initial three (3) years of officiating at Level 1.

¹ The CES Officiating Review will not be applied, by decision of the FEI Board on 5 June 2024.

Level 2 Jumping Course Designers

Requirements

Level 1 Course Designers wishing to be listed as a Level 2 Course Designer must:

- ✓ Achieve an English proficiency grade of B1 or higher
- ✓ Have been listed as an FEI Level 1 Course Designer for a minimum of two (2) years
- ✓ Have officiated as a Course Designer Level 1 at twelve (12) competitions with 135cm and four (4) competitions with 140cm
- ✓ Have officiated as an Assistant Course Designer at three (3) CSI2* or above with a Mentor Course Designer Level 3 or above, with positive recommendations

National Course Designers from NFs with Equivalency wishing to be listed as a Level 2 Course Designer must:

- ✓ Be formally recommended by their National Federation
- ✓ Achieve an English proficiency grade of B1 or higher
- ✓ Complete the online Jumping Foundation Course
- ✓ Have officiated as an Assistant Course Designer at one (1) CSI2* or above with a Mentor Course Designer Level 3 or above, with positive recommendations

Education

For Level 1 Course Designers:

- ✓ Pass an in-person Transfer-up Level 2 Course for Course Designers with examination
If an examination is not passed, the Official is given the opportunity of a re-attempt after one (1) year.

For National Course Designers from NFs with Equivalency:

- ✓ Pass an in-person Transfer-up Level 2 Course for Course Designers with examination
If an examination is not passed, the Official is given the opportunity of a re-attempt after one (1) year.

Status

- ✓ On passing the Level 2 examination(s) and fulfilling all requirements, participants are listed as Level 2 Course Designers in the FEI Database

Roles at FEI Events

According to FEI Jumping Rules Art. 259, Level 2 Course Designers may take on the following roles at FEI Events:

- ✓ Assistant Course Designer
- ✓ Course Designer (build up to 145cm)

Maintenance

To maintain status, Level 2 Course Designers must:

- ✓ Pass a CES Online Assessment every year
- ✓ Pass a CES Maintenance Course every three (3) years
- ✓ Have officiated as a Level 2 Course Designer or Assistant Course Designer at least at three (3) International Events within three (3) years*¹

*condition not applicable to Equivalency Officials for the initial three (3) years of officiating.

Level 3 Jumping Course Designers

Requirements

Level 2 Course Designers wishing to be listed as a Level 3 Course Designer must:

- ✓ Achieve an English proficiency grade of B2 or higher
- ✓ Have been listed as an FEI Level 2 Course Designer for a minimum of two (2) years
- ✓ Have officiated as a Level 2 Course Designer at least at three (3) International Events
- ✓ Have officiated as a Level 2 Course Designer at eight (8) competitions with 145cm, out of these four (4) with a Jump-Off
- ✓ Have officiated as an Assistant Course Designer at three (3) CSI4*/5* (160cm), with a Mentor Course Designer Level 3 or above, with positive recommendations

Education

- ✓ Pass an in-person Transfer-Up Level 3 Course for Course Designers with examination
If an examination is not passed, the Official is given the opportunity of a re-attempt after one (1) year.

Status

- ✓ On passing the Level 3 examination(s) and fulfilling all requirements, participants are listed as Level 3 Course Designers in the FEI Database

Roles at FEI Events

According to FEI Jumping Rules Art. 259, Level 3 Course Designers may take on the following roles at FEI Events:

- ✓ Assistant Course Designer
- ✓ Course Designer (build up to 160cm), except Olympic Games, the Youth Olympic Games, Continental Games, the World Championship, the Continental Championship for Seniors, the FEI Jumping World Cup™ Final and the Longines League of Nations™ Final

Maintenance

To maintain status, Level 3 Course Designers must:

- ✓ Pass a CES Online Assessment every year
- ✓ Pass a CES Maintenance Course every three (3) years
- ✓ Have officiated as a Level 3 Course Designer or Assistant Course Designer at least at three (3) International Events within three (3) years¹

Level 4 Jumping Course Designers

Requirements

Level 3 Course Designers wishing to be listed as a Level 4 Course Designer must:

- ✓ Achieve an English proficiency grade of B2 or higher
- ✓ Have been listed as an FEI Level 3 Course Designer for a minimum of three (3) years
- ✓ Be in good standing with the FEI

The following officiating experience has to be achieved within ten (10) years of the application:

- ✓ Have officiated as a Course Designer at a minimum of one (1) CSIO5* or three (3) CSIO2*/CSIOY (145cm) or above in the last six (6) years
- ✓ Have officiated as a Course Designer at a minimum of twelve (12) Grand Prix competitions 150cm or above at International Events in the last three (3) years
- ✓ Have officiated as an Assistant Course Designer at two (2) CSI5* with a Mentor Course Designer Level 4, with positive recommendations

Education

- ✓ Pass the Transfer-up Level 4 Education for Course Designers with examinations:

First phase:

- Pass online problem-solving case studies
If passed, invited to an online interview
- Pass an online interview
If passed, the Official is provisionally transferred up to Level 4 and invited to the second phase

Second phase:

- Pass a three-day in-person course at FEI HQ
If passed, the transfer-up to Level 4 is confirmed

If one of the two phases is not passed, the Official is given the opportunity of a re-attempt after one (1) year.

Status

- ✓ On passing the Level 4 examination(s) and fulfilling all requirements, participants are listed as Level 4 Course Designers in the FEI Database

Roles at FEI Events

According to FEI Jumping Rules Art. 259, Level 4 Course Designers may take on the following roles at FEI Events:

- ✓ Assistant Course Designer
- ✓ Course Designer (build up to 160cm), including Olympic Games, the Youth Olympic Games, Continental Games, the World Championship, the Continental Championship for Seniors, the FEI Jumping World Cup™ Final and the Longines League of Nations™ Final

Maintenance

To maintain status, Level 4 Course Designers must:

- ✓ Pass a CES Online Assessment every year
- ✓ Pass a CES Maintenance Course every three (3) years
- ✓ Have officiated as a Level 4 Course Designer or Assistant Course Designer at least at 3 CSI/O/W 3* Events within three (3) years¹
