We would like to remind you that the Bid Process for the FEI Jumping World Challenge Final 2020 is (still) open and can be initiated by any interested party.

The FEI Jumping World Challenge Final is open to 20 riders and maximum 2 wild cards (for Host NF if no Athletes have qualified through the normal process – Category A Regional Rankings) and is held on borrowed horses.

A financial contribution towards the organisational costs is allocated by the FEI to the Host National Federation.

## FEI Driving World Cup™ - 2020-2021 season

### Opening of bid process

The FEI is pleased to announce the opening of the bid process for the FEI Driving World Cup™ Legs\*, 2020-2021 season.

The process will run from **5 March to 3 April 2020**, and can be initiated by any interested party by submitting a Bid Application & Questionnaire to the FEI via the **FEI Online Bidding Platform**.

The applicable BID PROCESS TIMELINE is the following:

### Phase 1: Applicant Phase

5 March 2020	Bid Process opened.
3 April 2020	Deadline for submission of Bid Application & Questionnaire to the FEI via the FEI Online Bid Platform

### Phase 2: Candidate Phase

10 April 2020	Host Agreement sent to all Applicants.
8 May 2020	Deadline for Applicants to send back a signed version of the Host Agreement. Host Agreement to be signed by the Applicant and National Federation
May 2020	<b>Review Process:</b> The FEI Driving Committee reviews the applications, provided that the Host Agreement is signed by the Applicant and the NF, and provides the FEI Board with its recommendation.

### Phase 3: Decision Phase

June 2020	<b>Allocation Process:</b> The FEI Board will allocate the 2020-2021 legs of the FEI Driving World Cup™ during its in-person meeting.

## RULES

### FEI Dressage World Challenge Rules Update

Following the introduction of a Quality Score in the FEI Children Tests as of 2020, and the Directives for FEI International Dressage Competitions for Children published on 13 January 2020, the FEI Dressage World Challenge Rules have been updated in order to be coherent with these changes.

Articles 3.1 and 6.2 of the rules concerning the placement of the judges for the Senior I and Youth Classes (Children tests) have been revised and can be found **here**.

### ESEEs Link with Education of FEI Officials

### **Equivalency with “FEI” status**

National Federations that have organised Equestrian Sports Educative Events/ESEEs (education of national Officials) with the help of FEI Solidarity and **have in the continuity developed their own national education & certification system**, will be eligible to qualify for equivalency with the FEI Level 2 course/status.

We therefore encourage NFs without a proper national education system to work with their technical committees to achieve this objective. We also encourage NFs to exchange knowledge on a regional basis, for example: NFs with such a system to share their experience with the ones with no system.
