5* Dressage Judges

Five FEI 4* Dressage judges from Austria, Germany, Great Britain, Luxemburg and Sweden have been promoted to 5* status, the highest rank, by the FEI Dressage Technical Committee. The promotions, which will come into effect on 1 July 2018, will allow the judges to officiate at major FEI Dressage events, such as FEI Dressage World Cup™ Finals, FEI Championships at Grand Prix level, FEI World Equestrian Games™ and the Olympic Games.

The new 5* Dressage judges are:

These promotions will bring the total number of 5* Dressage judges to 40 (36 after 1 January 2019 due to retirements).

FEI World Equestrian Games™ Tryon 2018 Pre-Arrival Testing

Horses competing at the FEI World Equestrian Games™ Tryon 2018 can be tested for FEI Equine Prohibited Substances through the Pre-Arrival Testing service (PAT). This has previously been offered at the 2012 and 2016 Olympic Games as well as the 2014 FEI World Equestrian Games™ providing a full screening service allowing athletes and their entourage to confirm their horses are clear of all prohibited substances.

Testing will be carried out at the FEI's Central Laboratory LGC Ltd. in Newmarket (GBR). The PAT service is offered on a voluntary basis through the National Federations and for a limited time only before the scheduled arrival dates of horses at the Games' stables.
