- 10 March 2014: Host Agreement signed and sent back to FEI;
- 11 March 2014: FEI Bureau's decision on allocation.

2015 FEI Equine Prohibited Substances List deadline for submissions

Please use the **FEI Prohibited Substance List Suggestions Form** at the bottom of the linked page. All fields must be completed, including information regarding the substance, its use, application and specific reasoning for inclusion or change of category.

All submissions of FEI Prohibited Substance List Suggestions Forms for changes should be received by the **FEI Veterinary Department** no later than 21 February for consideration during 2014.

Nomination of Pony Measuring Veterinarians

We would like to remind our National Federations to name two Pony Measuring Veterinarians within their structures and to communicate these names to the **FEI Veterinary Department** by 22 February at the latest.

National Head Veterinarian (NHV) Collaboration with Governments to Improve International Movements of Competition Horses

The FEI regularly informs National Federations on its activities in the area of international movements of competition horses. We would like to emphasise to our National Federations that the role of the National Head Veterinarian is vital to the growth of the sport and that a close working relationship with national governments – particularly the veterinary services – is essential to facilitating the increased international movement of our horses.

National Federations are requested to ensure that their National Head Veterinarians have identified their key counterparts within their government veterinary authorities. National Head Veterinarians are encouraged to maintain effective communications with their government counterparts and to regularly report back to the FEI Veterinary Department, as per article 1007 of the **FEI Veterinary Regulations**. The FEI Veterinary Department will contact National Federations and their National Head Veterinarians shortly for further information.
