### LONGINES FEI JUMPING WORLD CUP™ QUALIFIERS, WESTERN EUROPEAN LEAGUE SEASONS 2021/22, 2022/23 AND 2023/24

#### Opening of bid process

The Bid Process for the Qualifiers of the LONGINES FEI Jumping World Cup™, Western European League, for the Seasons 2021/22, 2022/23 and 2023/24 that shall run from 19 June 2019 to 31 August 2019 can be initiated by any interested party by sending an email (expression of interest), via its National Federation, to the FEI at [bidning@fei.org](mailto:bidning@fei.org) and indicating its interest in hosting a Qualifier.

Once the expression of interest is received by the FEI, the interested party will be provided with the relevant hosting information and guided throughout the process until a final allocation decision is taken by the FEI Board.

The applicable BID PROCESS TIMELINE is the following:

### Phase 1 - Applicant Phase

19 June 2019	Opening of the Bid Process
31 August 2019	Deadline for Applicants to submit an expression of interest to host a Qualifier

### Phase II - Candidate Phase

Beginning of September 2019	Draft Host Agreement to be provided to Candidates
23 September 2019	Host Agreement to be signed by Candidate and National Federation and returned to the FEI
October 2019	FEI internal evaluation of bids

### Phase III - Decision and Allocation Phase

16 November 2019	Allocation decision by FEI Board, upon recommendation of the Jumping Committee

### Opening of bid process

The bid process for the FEI Eventing Nations Cup™ 2020 season will run from 19 June to 31 August 2019 and can be initiated by any interested party by submitting an expression of interest to the FEI via the **FEI online bidding platform**.

Beginning of September 2019	Draft Host Agreement to be provided to Candidates
30 September 2019	Host Agreement to be signed by Candidate and National Federation and returned to the FEI
October 2019	FEI internal evaluation of bids

### Phase III - Decision and Allocation Phase

16 November 2019	Allocation decision by FEI Board, and announcement of the host organisers of the FEI Eventing Nations Cup™ 2020 Season
