## **Update**

Since the launch of FEI Campus in June 2017, numerous new courses have been added to the platform. This includes four courses for Officials and over 30 Horsemanship courses with a further 15 planned for 2018. You will also find the annual discipline rule and guideline changes on FEI Campus explained by the Discipline Directors themselves in short compelling videos currently available for the disciplines of Endurance, Driving, Reining, and Vaulting.

FEI Campus is a living platform with a steady flow of content and courses being developed and planned throughout the year ranging from Officials related content to anti-doping, biosecurity, legal courses and language training. ## **INTERNATIONAL MOVEMENT OF HORSES**

### **IHSC - OIE Workshops**

International movement of sport horses is a key priority for the International Horse Sport Confederation (IHSC), a partnership between the FEI and the International Federation of Horseracing Authorities (IFHA) and the World Organisation for Animal Health (OIE) in order to facilitate movement and ultimately the development of equestrian sport. As a result a number of workshops covering key topics such as equine diseases and the roles of Customs and Veterinary Authorities in the movement of horses are being held around the world:

#### **Past workshops:**

- Johannesburg (RSA), 12 July 2017
- Guatemala (GUA), 12 October 2017

#### **Upcoming workshops:**

- Montevideo (URU), 16 November 2017
- Beijing (CHN), 1-2 February 2018
- Baku (AZE), June 2018 (exact date TBC)
