#### **FEI European Dressage / Para-Equestrian Dressage Championships for Seniors 2013 Herning (DEN), 19-25 August 2013**

Please be aware that the following changes have been made to the original schedule of the above Championships:

- The deadline for obtaining a certificate of capability is 3 July for Dressage and 7 July for Para-Equestrian Dressage.
- The following NFs have been added to the schedule: Albania, Andorra, Cyprus, Iceland, Latvia, Lithuania, Macedonia, Malta, Monaco and San Marino.

### FEI Equine Prohibited Substances List - Proposed changes for 2014

The FEI Equine Prohibited Substances List Group has considered updates to the 2014 Equine Prohibited Substances List (EPSL) in view of the proposals submitted to the Veterinary Department and other information received.

The current proposed changes to the 2013 FEI EPSL, based on recent advice from the List Group, can be consulted [here](#). These changes are subject to consultation, review and agreement. Any changes accepted will become effective from 1 January 2014.

Please submit any comments regarding these suggested changes, including clear scientific reasoning to [Victoria Unt](#) no later than **Friday 19 July 2013**. All comments will be considered further by the FEI Equine Prohibited Substances List Group before they finalise their conclusions on what should be on the FEI EPSL for 2014.

After 19 July, comments or proposals for changes to the List can continue to be submitted through the [Clean Sport webpage](#) but will generally not be considered until the 2014-2015 review process.

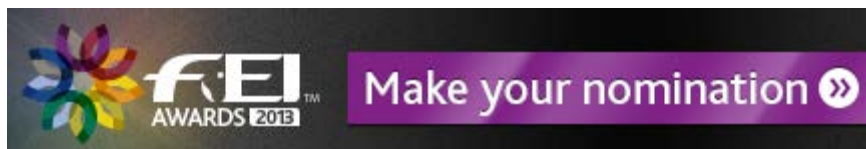

## Allocation of FEI Championships and FEI Finals

National Federations are invited to send applications to host and organise the FEI Championships and FEI Finals listed on the table that can be found on [FEI.org](#).

The information contained in the table is regularly updated by the FEI.

National Federations must send their applications no later than **1 December** to [bidding.championships@fei.org](mailto:bidding.championships@fei.org).

Nota bene:

Following the FEI General Assembly 2011 in Rio de Janeiro, a new article 106 of the FEI General Regulations (GRs) entitled "Application and Allocation of FEI-Named Events" went into effect on 1 January 2012.

According to article 106 GRs, the FEI Bureau decides on the final allocation of FEI-Named Events, in principle during its spring meeting (the exact date is confirmed by the FEI on a yearly basis).

### **Allocation Time**

The Allocation Time is as follows:

- FEI World Equestrian Games™: five (5) years prior to the Event;
- FEI World Cup™ Finals Jumping, Dressage, Eventing, Driving and Vaulting, FEI Continental Championships for Seniors (in all disciplines) and FEI World Championships in Driving, Endurance, Vaulting and Reining: three (3) years prior to the Event;
- Other FEI Championships will be allocated two (2) years prior to the Event.

### **Deadline for Applications**

National Federations must apply no later than **1 December** of the year preceding the allocation by the FEI Bureau of the relevant FEI-Named Event (or any other date as may be decided by the FEI Secretary General).

Example: If you wish to apply for the FEI European Eventing Championships for Young Riders 2016, the allocation by the FEI Bureau will take place, in principle, during its meeting in spring 2014, so you must send your application to the FEI by **1 December 2013 at the latest**.
