- 2 passed Shadow Judgings Level 1 at Intl. Shows (CVIs) or online Compulsory, Free and Technical Tests - Horse Score Compulsory Test (1, 2, 3) - Exercise Score

Free Test - Technique Score (Performance, Degree of Difficulty)

Passed online Level 1 Judges Equivalency examination

#### **For Level 1 Judges**

- English proficiency grade of B1 or higher
- 1 year & 3 Intl. Shows (CVIs) as a Level 1 Judge

# Maintenance

- CES Online Assessment every year
- CES Maintenance Course every 3 years
- 3 Intl. Shows (CVIs) within the last 3 years as a Level 2 Judge\* - one may be replaced by a Vaulting Challenge 1
