Requirements

- ✓ English proficiency grade of C1 or higher
- ✓ Level 3 Official Veterinarian for a minimum of 3 years
- ✓ Be in good standing with the FEI
- 5 FEI Events* as a Veterinary Delegate or Foreign Veterinary Delegate

*Cls, ClOs, Children's Classics, Challenge Finals, Nations Cups or Regional Championships

- CES Online Assessment every year ____
- CES Maintenance Course every 3 years
- Licensure confirmation & good standing with the Veterinary Regulator of registration, via Annual Disclosures Declaration
- 1 FEI Event every 3 years as a Veterinary Delegate, Foreign Veterinary Delegate, President or Member of the Veterinary Commission ¹

Education

For Transfer-up

Pass the Level 4 Official Veterinarian Education with examination(s):

Pass online problem-solving case studies If passed, invited to an online interview

Pass an online interview If passed, the Official is provisionally transferred up to Level 4

Pass a three-day in-person course at FEI HQ If passed, the transfer-up to level 4 is confirmed

Status

Level 4 Official Veterinarian

On passing the Transfer-up Level 4 Education with examinations for FEI Veterinarians and fulfilling all requirements, applicants are listed as Level 4 Endurance Official Veterinarians in the FEI Database





Roles as set forth in Annex IX of the FEI Veterinary Regulations

Requirements

- English proficiency grade of B2 or higher
- Level 2 Official Veterinarian for a minimum of 3 years
- 10 FEI Events as a Veterinary Delegate or Additional Veterinary delegate
- Level 2 Official Veterinarian for 9 consecutive years
- 6 FEI Events as a Veterinary Delegate or Additional Veterinary delegate

Maintenance

- ✓ CES Online Assessment every year
- CES Maintenance Course every 3 years
- Licensure confirmation & good standing with the Veterinary Regulator of registration, via Annual Disclosures Declaration
- 1 FEI Event every 3 years as a Veterinary Delegate, Additional Veterinary Delegate, Foreign Veterinary Delegate or Member of the Veterinary Commission 1 ¹ The CES Officiating Review will not be applied, by decision of the FEI Board on 5 June 2024.

Education

For Transfer-up

- First Discipline: On fulfilling all requirements, applicants have passed the transfer-up education
 - Additional discipline(s): Shadow officiate* at 1 FEI Event with an FEI Mentor Official (Level 3 or 4 Official Veterinarian)
 - *A positive recommendation is required for each shadow officiating
