3. Introduction to the Venue

3.1 Introduction

Located in Yaolin Town, Tonglu County, the Tonglu Equestrian Centre is 25km outside Tonglu City and approximately a 1.5-hour drive from Hangzhou. It was designed and constructed in accordance with specifications of international equestrian events. With a total investment of around RMB560 million, the centre covers an area of about 37.3 hectares with a floor area of approximately 54,000 square metres. The main arena is designed in the shape of the Chinese character for "horse" (\beth) when viewed from above. Specifically, the well-appointed Tonglu Equestrian Centre is comprised of an 80 x 100-metre main arena, an indoor training ground with an area of 5,000 square metres, two 60 x 80-metre outdoor training/warm-up arenas, seating for 3,100 people, a cross-country track of approximately 4km, a grooms' residential zone, stables, hospital for horses and feed warehouse. 

3.2 Stable Plan

Stables/grooms' residential zone: There are 240 stalls divided into five stable blocks. Each stable block comprises four distinct zones, each comprising 12 stalls. Twelve stalls are reserved for a medication control sample collection station.

Each stall is monitored by CCTV cameras. Each zone has a feed warehouse, a saddle room and supporting facilities, including washing machine, refrigerator and ice machine. In addition, there are two horse weighing scales and a farrier station with a forge.

The grooms' residential zone is close to the stables compound. There are a total of 138 rooms, including 130 twin rooms and eight single rooms, which can accommodate up to 268 guests. (See images 3 and 4 for layout of stables – green – and grooms' accommodation — orange.)





3.3 Veterinary Facilities

3.3.1 Veterinary Hospital

A purpose-built Veterinary Hospital with a total floor area of 778 square metres is located adjacent to the stables compound. The hospital contains two open-fronted treating bays, three treatment stables, an examination area with stocks, an operating theatre with two induction/recovery boxes, a pharmacy/dispensary, clinical laboratory and office. 

3.3.2 Cooling Stations

Four cooling stations are provided at strategic locations throughout the venue. These are comprised of a shade tent, their sides lined with fans, and insulated tanks containing ice and water. The four stations are located in the training area, adjacent to the warm-up arena's entrance and exit, close to the start of the cross-country course and at the end of the cross-country course, respectively.

6. Veterinary Hospital

6.1 Operating Hours

Veterinary Hospital Asian Games Opening Hours:

20 Sept — 08 Oct 2023: 06:00 – 21:00 (emergency services 24 hours)

Lab Opening Hours:

20 Sept - 08 Oct 2023: 07:00 - 18:00 (emergency services 24 hours)

Farrier Service Hours:

21 Sept — 08 Oct 2023: 07:00 – 21:00 (emergency services 24 hours)

6.2 General Services

The Veterinary Hospital will provide the following facilities and services:

- Routine clinical and diagnostic services
- Treatment stables
- Emergency surgery and intensive care
- Clinical laboratory/pharmacy/dispensary
- Isolation stables
- Necropsy facilities

6.3 Routine Clinical and Diagnostic Services

During standard Veterinary Hospital operating hours, the Veterinary Services Team will be available to perform and support the following services upon request:

- Routine clinical examination and health check-up
- Detailed diagnostic investigations on request
- Radiography
- Ultrasonography
- Endoscopy
- Surgery under general anaesthesia if required (24–hour emergency cover provided).

Routine services listed above must be booked in advance at the Veterinary Hospital reception in person. Please contact Dr. Yao Congbin for further details.

6.4 Treatment Stables

Five treatment boxes will be available inside the Veterinary Hospital compound for team veterinarians to facilitate horse treatment if required (two open-fronted bays and three stables). Team veterinarians will be welcome to use these facilities by appointment.

6.5 Clinical Laboratory

The diagnostic laboratory in the Veterinary Hospital will provide a range of essential services throughout the Games, including:

- Haematology/biochemistry
- Cytological examination of tracheal wash samples
- Blood gas/lactate analysis
- Urinalysis

A list of the full range of tests will be available at the Veterinary Hospital reception. Please contact Dr. Carly Liu or Dr. Yao Congbin for further details.

6.6 Dispensary/Pharmacy

The range of routine Western veterinary drugs normally available in the Mainland is highly limited. Special arrangements have been made to import medications required to treat clinical conditions that are likely to be encountered. These will be available for purchase by team vets strictly on an "as needed" basis, or will be administered by hospital vets as required. (A list of the products that will be available is included in Appendix 2.)

The Veterinary Hospital will stock a minimal quantity of products that may be required for routine "maintenance" therapy (such as joint therapies). Similarly, the Veterinary Hospital will only stock intravenous fluids that are required for a clinical indication, which will include rehydration therapy after the cross-country phase of the eventing competition.

Any team that wishes to treat their horses with maintenance drug therapies or administer fluids when there is not an obvious clinical indication must arrange to import their own supply of these products with the rest of their equipment. The process that must be followed to obtain permission to import drugs and fluids is documented later in this guide.

The Veterinary Hospital will not stock nutritional supplements, although a small range of these will be available. Teams wishing to import their own supplement must liaise directly with the Organising Committee to make such arrangements.

6.7 Necropsy

A necropsy service will be provided in order to comply with Customs and FEI requirements. This service will take place in the post-mortem room in the hospital or the isolation centre.

6.8 Isolation Stables

An Isolation Compound is located to the southwest of the cross-country field. There are 10 air-conditioned stables and accommodation for grooms inside the isolation area.

All horses will have their rectal temperature taken on arrival at the venue by the FEI Veterinary Commission. Horses displaying suspicious signs, including high temperature, coughing, diarrhea, etc, will be sent to isolation boxes with their grooms. Other horses that have been within their vicinity during transportation will also be observed carefully.

Samples for testing will be taken by Customs and horses will be contained in isolation boxes until negative test results are obtained.

6.9 Billing

Charges will be levied for veterinary services, including diagnostic imaging, lab testing, medicines, consumables, surgery, etc.

Team veterinarians or persons responsible will be required to settle their team's account within seven days. Payment by Visa credit card is preferred. Teams should note that no credit cards other than Visa/Unipay will be accepted. All accounts must be settled in full before horses are released at the end of the competition.

7. Farrier Services

A purpose-built forge will be installed in a temporary building in the centre of the stables compound. This will be fully equipped to provide routine and more specialist farrier services in a safe, spacious environment. The forge will be staffed by two highly experienced international farriers working together with a local team, all of whom will be available to serve teams who do not have a farrier and support those who do. The forge will routinely operate over the same hours as the Veterinary Hospital and will be available for use by team farriers on a pre-booked basis. The farrier team will also provide a 24-hour emergency service.

Farrier support will be provided in the vicinity of training and competition areas during their operation and the farrier team will be happy to provide assistance and advice regarding any aspect of farriery to both riders and team farriers as required.

The forge will stock a reasonable selection of modern materials and shoes. However, all teams are strongly advised to bring their own shoes and shoeing materials in preparedness to replace worn or lost shoes, especially if any of their horses have special requirements.

8. FEI Veterinary Commission

8.1 FEI Regulations

All horses will be considered to be under FEI regulations from their time of arrival at the venue. The relevant regulations are listed below:

- FEI Veterinary Regulations 15th Edition 2023
- FEI Equine Anti-doping and Controlled Medication Regulations 3rd Edition 2023
- FEI General Regulations 24th Edition 2023

8.2 Registration of Team Veterinarians and Equine Physiotherapists

All veterinarians must be registered by the FEI as Permitted Treating Veterinarians. Equine physiotherapy services will not be available on site. All equine physiotherapists nominated by national federations must be registered with the FEI as Permitted Equine Therapists.

All team veterinarians and equine physiotherapists must register at the Veterinary Hospital and with the FEI Veterinary Commission after arriving at the equestrian venue. FEI ID cards will be checked. Team and individual competitors' veterinarians and equine physiotherapists must provide a list of horses under their care. Team and individual competitors' veterinarians must provide their contact details (including mobile phone numbers) to both the Veterinary Hospital and the FEI Veterinary Commission in order to ensure they can be reached in case of emergency.

Team veterinarians will not be able to use any Veterinary Hospital facilities, submit samples for clinical pathology, obtain veterinary stock or enter the stables area until they have registered upon arrival. All veterinarians must carry their FEI Permitted Treating Veterinarian ID cards in addition to their Asian Games accreditation. All equine physiotherapists must be registered under a registered veterinarian. All physiotherapy equipment must be approved prior to use.

8.3 Importation of Horses into China

Peden Bloodstock GmbH has been appointed as the equine shipping agent working with China's COSCO. Peden Bloodstock GmbH will coordinate the logistics of international transportation of all horses (import and export) and also ground transportation from/to Hangzhou International Airport and Tonglu Equestrian Centre.

Further details regarding transport and equine logistical matters are provided in the Equine Freight Manual.

8.4 Arrival Examinations

Horses will be subject to a brief examination by Customs officials at Hangzhou International Airport. Once the horses have arrived at Tonglu Equestrian Centre, the FEI examination will be performed by the FEI Veterinary Commission/veterinary clinical team in accordance with FEI Veterinary Regulations Article 1029.

As per FEI Veterinary Regulations, horses displaying any sign of infectious disease will be monitored and rechecked, and if necessary transferred to an isolation compound. All competition horses must have an FEI passport or an FEI recognition card with an FEI-approved national passport as per the FEI Veterinary Regulations and FEI General Regulations. Influenza vaccination status will be checked in each horse's passport and must comply with FEI Veterinary Regulations Article 1003.

8.5 FEI Horse App

As per FEI Veterinary Regulations, horses' temperatures must be recorded in the FEI Horse App by the person responsible for three full days prior to the date of the arrival examination and twice daily while at the venue. Although the arrival examination will be performed shortly after a horse's flight, it is understood that it is not possible to record the horse's temperature while in transit. The FEI will be provided with a list of horses on each flight along with the flight information and times to accommodate this. Temperature must be recorded before the horse is loaded onto the flight and again at the examination upon arrival.

8.6 Biosecurity

Horses will be under strict biosecurity control during transport and throughout their stay at the venue during the Games. Foot mats with disinfectant and hand sanitiser must be used upon entry and exit from the horse area. All team veterinarians must comply with Customs officials' requirements. The person responsible and the team veterinarian are responsible for notifying the FEI Veterinary Commission and biosecurity manager of any horse with a rectal temperature higher than 38.5 degrees C, or displaying any sign of either neurological or infectious disease. The biosecurity manager will be required to notify Customs officials.

8.7 Further Customs Examinations and Testing

All horses are required to have blood and nasopharyngeal samples taken within 24 hours of arrival to fulfill Customs requirements. Samples are to be taken by team veterinarians or can be taken by the on-site veterinary team if requested. Samples must be taken in the presence of Customs officials.

Customs requires recording of a horse's temperature twice daily from arrival until departure from the venue. This information will be provided to Customs via the FEI Horse App.

8.8 FEI Veterinary Commission Briefing to Team Veterinarians

Briefing to all vets will be conducted with teams' vets within 48 to 72 hours of horses' flight arrival – exact times to be confirmed.

8.9 Horse Inspections

All horse inspections will take place adjacent to the main field of play. Inspection times are listed in Part 4 of this guidebook.

8.10 Equine Anti-doping and Controlled Medication Testing

Equine anti-doping and controlled medication testing will be carried out in accordance with the FEI Equine Anti-Doping and Controlled Medication Regulations, FEI Veterinary Regulations and FEI Equine Prohibited Substances List. Horses can be selected for testing at any time during the period of the event. The appointed FEI testing veterinarian will liaise with the president of the ground jury and the FEI Veterinary Commission. The testing process for horses will be led by the FEI Veterinary Department and, in the event of a dubious finding, subsequent processes will be managed by the FEI Legal Department. Materials and substances suspected to have been used to treat horses in contravention of the FEI Veterinary Regulations may also be subjected to testing.

8.11 Treatments

All treatments, except for nebulisation with non-prohibited substances, must take place within the designated treatment stables as per the FEI Veterinary Regulations. Intravenous fluid therapy must be performed within the designated treatment stables with the exception of fluids administered following cross-country activity. The FEI Veterinary Commission may allow Chapter IV fluid therapy to be administered in a horse's stable on an individual needs basis.

It is the responsibility of the team veterinarians and persons responsible to comply with the FEI Veterinary Regulations. Specific attention should be paid to the following regulations:

*FEI Veterinary Regulations Chapter V:

Particularly with respect to same-day treatments, fluid therapy, veterinary forms and authorisation of treatments.

*FEI Veterinary Regulations Article 1004 Prohibited Methods:

Particularly with respect to prohibited methods such as removal of sensory hairs and clipping or shaving of a horse's limbs during the period of the event. Horses with sensory hairs removed will be disqualified.

*Treatment Authorisation and Veterinary Forms:

The protocols to be followed during the 2022 Asian Games were established for use at the 2020 Tokyo Olympic Games. The objective is to ensure the welfare of horses and athletes, taking into account lengthy travel times and on-site precompetition time while also maintaining a level playing field for all competitors.

*Treatments in Pre-Competition Period:

A Veterinary Form A may be submitted to the FEI Veterinary Commission should a horse require emergency treatment with a controlled medication shortly before the start of the event. If a horse that has been treated under these circumstances is selected for Equine Anti-doping and Controlled Medication testing during the event, the Veterinary Form A will be taken into account during the evaluation of the test result. The form will be used to determine whether any substance detected has arisen from legitimate use of the medication with respect to pharmacokinetic data. Findings that do not correlate with the legitimate use of medication will be considered as Adverse Analytical Findings.

From the time of a horse's arrival and during the FEI jurisdiction period until three days (72 hours) prior to the horse's first inspection, the FEI Veterinary Commission will retroactively accept (without examining the horse) Form A exclusively for substances listed on the FEI List of Detection at the dosages presented in that list or less with the following restrictions: phenylbutazone, 1 dose only, iv 4.4mg/kg. The following substances cannot be used under this protocol: Clenbuterol, dembrexine, triamcinolone, methylprednisolone.

Please refer to the table on the following page for a summary of treatments permissible at specific periods. For treatments not listed, FEI rules apply.

8.12 Heat and Humidity

Countermeasures will be in place based on the FEI's heat and humidity protocols that were successfully followed at the 2020 Tokyo Olympic Games. On-site heat countermeasures include:

- Air-conditioned stables
- Constant monitoring of current and forecast climatic conditions via on-site Wet Bulb Globe Temperature index (WBGT)
- Monitoring of horses during training, warm-up and competition, including using thermography
- Assistance to team veterinarians in early detection of horses at potential risk of overheating
- Competition schedule times may be adjusted based on local on–site predicted
 WBGT index
- Four cooling stations with five cooling tents on—site along with a mobile cooling unit to be used on course

9. Special Procedures

9.1 Procedure for Vets to Obtain Temporary Registration

All overseas veterinary services personnel must obtain a Temporary Practicing Qualification Certificate of Veterinarian issued by the Ministry of Agriculture and Rural Affairs. Please see Appendix 1 and carefully complete the application form.

9.2 Provision of Drugs, Fluids and Other Resources
