Dear Colleagues;

Hoping all is going as well as possible in your preparations for Tokyo 2021 in these different circumstances and that your travels to Tokyo will be as uneventful as possible.

The following is to complement information presented in the Veterinary Guide and to present some operational details concerning the Olympics and Paralympics. It may not contain all the complete and final information but it is as much as what can be presented at this time reflecting that because of COVID mitigations, on-site visits and in-person meetings have been impossible.

Additional and further details regarding the Clinic organisation and services will be provided as needed by the VSM group (Dr Hiroko Aida and Dr Christopher Elliott).

The information is organised under the following main categories

- Clinic schedule and organisation
- Horse transport and arrival process
- Sport (FEI) rules application

Clinic schedule and organisation :

- Associate VSM Christopher Elliot is now on the ground at EQP and the clinic is getting set up and organised.
- The imaging (3 radiographic units and 3 ultrasound units) and laboratory equipment has arrived and is being set up.
- The Clinic will be operational when the first horses arrive (July 13 am, Australia dressage 2 horses)
- Farrier services: the forge will be set-up by July 12. For July 13 – July 18 period farriery services will be covered by Japanese farriers assisted by Emma Cornish (July 16 onwards). Farrier NTO Ben Benson will arrive on site July 19 onwards until the end of the OGs.
- Surgery services: the surgery facility onsite is operational and surgery back-up will be provided by JRA surgeons Takuto Minami and Kota Toju until NTO surgery Team Leader Bill Hay arrives July 19 for the duration of the OGs.
- The Medication list that was circulated and the LRS fluid reserve is expected any day
- The cooling stations and ice water supplies will be organised as was during the Test Event with better and bigger misting fans.
- Team leaders and Collaborators are confirmed and travel details etc. are almost all finalised

Horse Flights and Arrivals process:

- The horse flights are as per the Peden schedule
- Airport process: a visual check will be done as horses are unloaded from planes, no temperature monitoring will take place unless obvious clinical signs are observed
- Arrival Exams at EQP will take place as horses arrive onsite and will be conducted in the horse's own stalls, as per FEI rules and the Tokyo 2021 Biosecurity and Standard Operating Procedures protocol.

Sport (FEI) rules application

Treatment stalls Protocols :

- All injectable treatments with non-prohibited substances will be done in the Clinic treatment stalls.
- Use of the Clinic treatment stalls will be by appointment with the Clinic administrator (Dr Penny Dow.) Appointments for groups of same team horses will be encouraged.
- The Clinic treatment stalls will be disinfected following their use by each Team or individual horse

Treatment authorisations and Veterinary Forms

The following directive will apply to treatment and use of Veterinary forms during the 2021 Tokyo Olympic Games. (These protocols were established with the objective of ensuring the welfare of the horse as an Equine athlete, to take into account the extended travel time and on site pre-competition period as well as to best maintain an even playing field for all competitors.)

– ***Ref * Treatments in Pre-Competition period:***

*From the time of horse arrival and during the FEI jurisdiction period until 3 days (72 hours) prior to the 1st Horse Inspection, the Vet Commission will retroactively accept (without examining the horse) Form A's exclusively for **substances listed on the " FEI list of Detection Times" at the dosages presented in the FEI List of Detection or less with the following restrictions (phenylbutazone, 1 dose only, iv 4.4mg/kg). The following substances cannot used with this protocol (Clenbuterol, Sputolysin, triamcinolone, methylprednisolone)***
