My journey in equestrianism began in 1989 as a rider, and a decade later, I dedicated myself to volunteering for the sport. Over the past 25 years I have served as a Director of a National Federation, held position on the Executive Board of the Continental Association, served on the FEI's Audit Compliance Committee, and chaired FEI Regional Group VIII for the past two terms. Currently, I am also in my second term as FEI Vice President.
