# 2018 Conformity Seminar Summary

The following items were considered by the active FEI Eventing Course Directors at their Conformity Seminar. The discussions lead to the following discussion topics and proposals were submitted to the Eventing Committee.

### 1. Eventing Education System

- Review of future Education Systems
- FEI Campus and Online Education
  - E-Learning Courses
    - Foundation Course to be finalised by the Eventing Author Leader. The Foundation course is defined as an online programme aiming to prepare for FEI officiating in Eventing. Available to all public. Programme to be followed by all officials before attending a FEI Eventing Course.
  - Face to Face Seminars
    - Complement of the online courses to assess knowledge and experience including course country course walks, exchange of information/experience, assessing integration in teams and working under pressure
  - Level 1 Courses
    - Syllabus to be developed by the FEI and course to be integrated in the Course Concept.
  - Competency Test
    - Principle to be further developed for all Eventing Tests (Eventing specific questionnaires, to be passed by all participants as well as those seeking transfer) to be linked with the online learning as an education tool and certification of level.
  - Officials Evaluation for transfer
    - System to be updated for 2019 to include e-learning with online examination, practical experience (shadowing), active officiating evaluation and assessment at course.
    - Criteria for Assessors to be set and list to be published.
- 2017 Courses (incl. Warendorf 2018 Level 3 seminar) review
- FEI Level 2 course, Structure, Material & Rules 2018
  - Syllabus and Course Concept to be reviewed, as well as evaluation forms.

#### 2. Feedback from Course Directors

- Education tools for Course Directors (teach the teachers) to be developed
- Production of course material to be standardised for FEI level 2 courses

#### 3. New themes and structure for courses in 2018

- Risk Management including:
  - o Dangerous Riding: sanctions, hearings (verbal warning...)
  - o Importance of Reporting/providing information after a fall
  - o Preparation SIM
  - o Review of cross country course to ensure standard of level
