FEI Statutes, Article 39.2 – Penalties and Enforcement: All penalties imposed by a competent body of the FEI or the CAS shall be accepted by all National Federations and enforced by the FEI and all National Federations concerned.

EAD Rules Article 13.4 + ECM Rules Article 13.4 + ADRHA Article 15.3 - Recognition of Decisions by FEI and National Federations: Any decision of the FEI regarding a violation of the Rules (EAD Rules, ECM Rules, ADRHA) shall be recognized and enforced by all National Federations (including with respect to National Events), and National Federations shall take all necessary action to render such results effective.

NB. The mandatory Public Reporting does not apply to cases involving Minors, in accordance with Article 13.3.5 EADCMR. Information in relation to Minors are therefore not published. For any questions concerning cases involving Minors, please contact the FEI Legal Department.
